THE COURT FINDS that the enforcement of offenses involving the parking of vehicles is an integral part of public safety, access to private and public enterprises which depend on the appropriate use of parking spaces, and neighborhood livability of our community.

THE COURT FURTHER FINDS that the bail on parking offenses has not been increased since June of 2006, and that as part of a regular, periodic review of the parking offense bail schedule, the Court and the City of Portland Bureau of Transportation have determined that, in order to maintain parity with similar sized cities, and promote compliance with parking ordinances, the parking offense bail schedule must be adjusted.

THE COURT ORDERS that the following schedule for bail on parking offenses shall be effective November 30, 2009 for all citing agencies.

IT IS FURTHER ORDERED that any parking offense not listed on this schedule shall have a bail amount of \$70.00.


IT IS FURTHER ORDERED that bail for the following offenses shall increase as described below on January 4, 2010.

IT IS FURTHER ORDERED that implementation of the new schedule shall occur only as officers who enforce parking offenses in various jurisdictions are provided with the appropriate citations which contain notice to defendants of the new bail amounts. The current citations may continue in use until exhausted or replaced, and the bail amounts stated on those citations will be accepted by the Court for purposes of its rules regarding the appearance of a defendant on a parking citation.

IT IS FURTHER ORDERED that if the defendant has not appeared as provided by the rules of the Court, the bail amount for the parking offense may be doubled, but the bail may not exceed the maximum fine for the offense permitted by law. This order supersedes all previous bail schedules.
