HISTORY: The POLST template is being actively developed as a bi-state, Kansas and Missouri, initiative with the combined efforts of the University of Kansas and the Midwest Center for Bioethics

BARRIERS OVERCOME: Barriers presently are with the legislative and legal concerns about the present use of the DNR form and the issue of surrogacy.

STATE LAW AND REGULATIONS: These are being reviewed both in Kansas and Missouri presently. We have determined there is no impediment in KS. We are seeking repeal of an out of hospital DNR patient initiated **directive** statute in 2010 to ensure there is no question about interference. The new regulations for out of hospital DNR Orders in MO have taken effect. We have a ruling in writing by the Department of Health and Senior Services that POLST like initiatives are allowed, but it is likely that we will have to have any POLST like form (TPOPP) accompany the prescribed state form to be recognized by some EMS providers.
