Keynote Speaker

Dr. Denise Dudzinski, PhD, HEC-C
Professor, Department of Bioethics and Humanities
University of Washington

Dr. Dudzinski is Professor (Joint) in Bioethics & Humanities and Pediatrics, Division of Bioethics & Palliative Care as well as Fellow of the Hastings Center. She is Adjunct Professor in the School of Law and in the Department of Family Medicine at the University of Washington. She is Chief of the UW Medicine Ethics Consultation Service and Director of Organizational Ethics at Seattle Children's Hospital. She earned her PhD in Ethics from Vanderbilt University and her Masters of Theological Studies (MTS) from Vanderbilt Divinity School. She is also certified in healthcare ethics consultation through the American Society for Bioethics & Humanities (HEC-C).

Dr. Dudzinski developed an ethics curriculum for residency programs and teaches bioethics to health care providers, medical and nursing students, graduate, and law students at the University of Washington and affiliated hospitals. Her research includes methods and practices in ethics consultation; clinical and organizational ethics; pandemic ethics; ethical issues in transplantation and mechanical circulatory support; large-scale adverse event disclosure; competent refusal of nursing care; moral distress; and ethical issues in end-of-life care.

- Explain the ways in which structural inequities through policy, legislation, etc... negatively impact marginalized patients and their loved ones
