POLICY STATEMENT:

AFFILIATE APPOINTMENTS:

Affiliate faculty appointments are unranked, unpaid faculty appointments given to selected qualified professionals in the community to recognize their commitment and service to the School of Nursing. Affiliate faculty appointments are for two year terms and are renewable. School of Nursing students are not eligible for affiliate faculty appointments.

Affiliate faculty appointments can be requested by Specialty Directors, Program Directors, Associate Deans, or the Dean. These appointments are managed by the School of Nursing Office of Academic Affairs and Letters of Offer are extended by the School of Nursing Senior Associate Dean for Academic Affairs. Requests for an affiliate faculty appointment come to the Office of Academic Affairs in writing using the Affiliate & Joint Faculty Appointment Request form (see Appendix A).

RANKED JOINT APPOINTMENTS

A ranked joint appointment may be requested if the individual seeking this designation has a paid OHSU faculty appointment in another unit. The School of Nursing will determine rank based the school's current criteria for rank. The School of Nursing Appointment, Promotion, and Tenure Committee must approve ranked appointments at the rank of associate professor or above and ranks may differ between the OHSU school and/or units.
