Biography - Historical Note

Physician, A. D. Mackenzie died in 1907. He was known as “Little Mackenzie” in reference to, colleague, Kenneth A. J. Mackenzie, 2nd dean of the University of Oregon Medical School. He was appointed as lecturer in 1902 in clinical medicine and to give clinics at St. Vincent’s Hospital. He also gave clinics in the county hospital.

Scope and Contents Note

The collection consists of letters to patients and letters as an officer of the Oregon State Medical Society and the Portland City and County Medical Society. The materials were originally in 2 bound volumes. They were deconstructed for preservation digitization. The paper is fragile with acidic browning on edges and foxing. Ink is fading and appears to have been water damaged at some time.
