

# SAS License Agreement

Subject to the provisions contained herein, the Associate (Department) may use the SAS Institute copyrighted computer software products which Oregon Health & Sciences University has provided in accordance with its agreement with SAS Institute Inc. for use on university-owned computers on campus, including student computing labs, and at home for academic instruction or research use only. For each copy you use on a home computer, you must license a copy for use on an OHSU owned computer used on campus and the software can only be used on one machine at a time. Students may purchase a license, however, it must be used on a personally owned computer only – it cannot be installed on a University owned machine.

1. You acknowledge that these products are copyrighted and the SAS Institute Inc. retains all title and ownership rights to the products. The Associate agrees not to copy or permit others to copy the products, in whole or in part and agrees not to remove any labels from media
2. You agree to use the products under this agreement only on a computer which is 1) owned or leased by Oregon Health & Science University or 2) owned by the Associate and further agrees that the products must remain under the Associate's control, and that resale or other transfer is explicitly prohibited. This software may not be used outside of the United States
3. You agree to use the products only for the Associate's or Oregon Health & Sciences University own data processing requirements for academic instruction or research use only, and not for commercial time—sharing, rental or service bureau use
4. You agree not to create, or attempt to create, or permit or help others to create, the source code from the products furnished under this agreement. The Associate agrees that it will not reverse engineer or decompile the products
5. You agree to return to the library or your department at Oregon Health & Science University any and all copies in the Associate's possession and to forward written notice to Oregon Health & Science University that all programs and materials containing the products have been destroyed or deleted from all computer libraries and storage devices, are no longer in use or usable by Oregon Health & Science University should the Associate no longer be associated with Oregon Health & Science University or if advised by Oregon Health & Science University that the site license with SAS Institute has been terminated.
