### Steven Tam

Steven Tam, M.D., is an assistant clinical professor in geriatrics at the Department of Internal Medicine at University of California, Irvine School of Medicine. Dr. Tam also performs elder abuse assessments at The Elder Abuse Forensic Center of Orange County, where he reviews and evaluates cases of elder abuse, and works with an interdisciplinary team involving law enforcement, Adult Protective Services, the district attorney's office, ombudsmen and other agencies.

### Lisa Burnett

Lisa Burnett, M.Ed., is a clinical services specialist at Multnomah County Adult Protective Services. Ms. Burnett, originally a graduate of University of Oregon, brings twenty years of experience in working in adult protective services.

### Wendy Hillman

Wendy Hillman, M.S.W., is a program supervisor at Multnomah County Adult Protective Services. She has worked in adult protective services for twenty years and has encountered a wide variety of victims, perpetrators and circumstances.

### Chuck Mickley

Chuck Mickley, J.D., is a deputy district attorney with the Multnomah County District Attorney's Office. Mr. Mickley joined the DA's office in 1998. Since 2009, he has been focused on the prosecution of elder financial abuse cases and other crimes against elderly and vulnerable victims.

### Annie Shoen

Annie Shoen, J.D., had been a deputy district attorney with the Multnomah County District Attorney's Office since 2005. In 2008 she began focusing on domestic violence offenses and the prosecution of elder abuse. Currently Ms. Shoen screens and prosecutes most elder physical abuse felonies referred to the office.

Mohammad Bader, M.S., L.P.C., is a program manager of Multnomah County Adult Protective Services and is currently on the board of directors of The National Committee for Abuse Prevention. Mr. Bader has over 25 years experience in social services and mental health fields.
