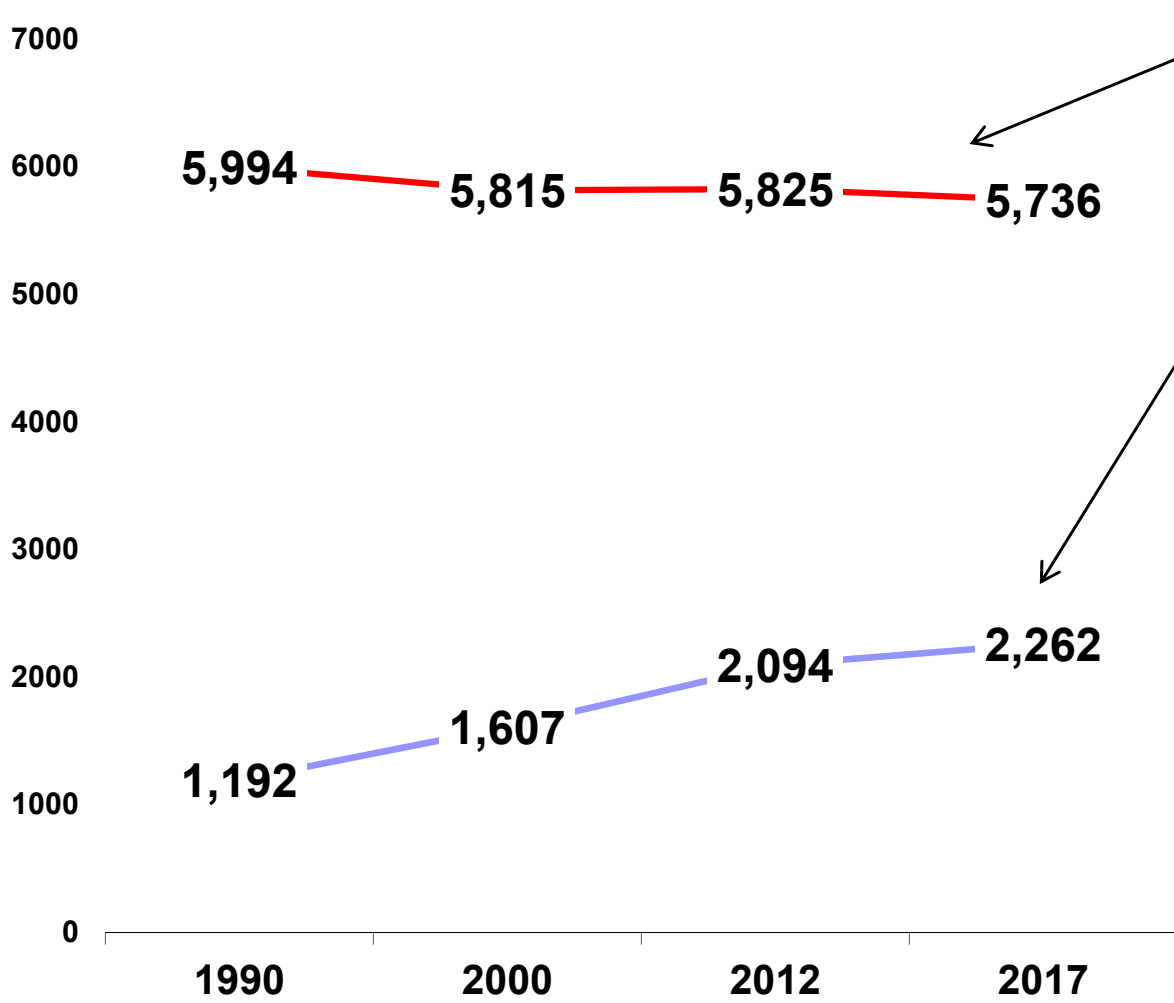

Service Area Population Change (1990-2017)



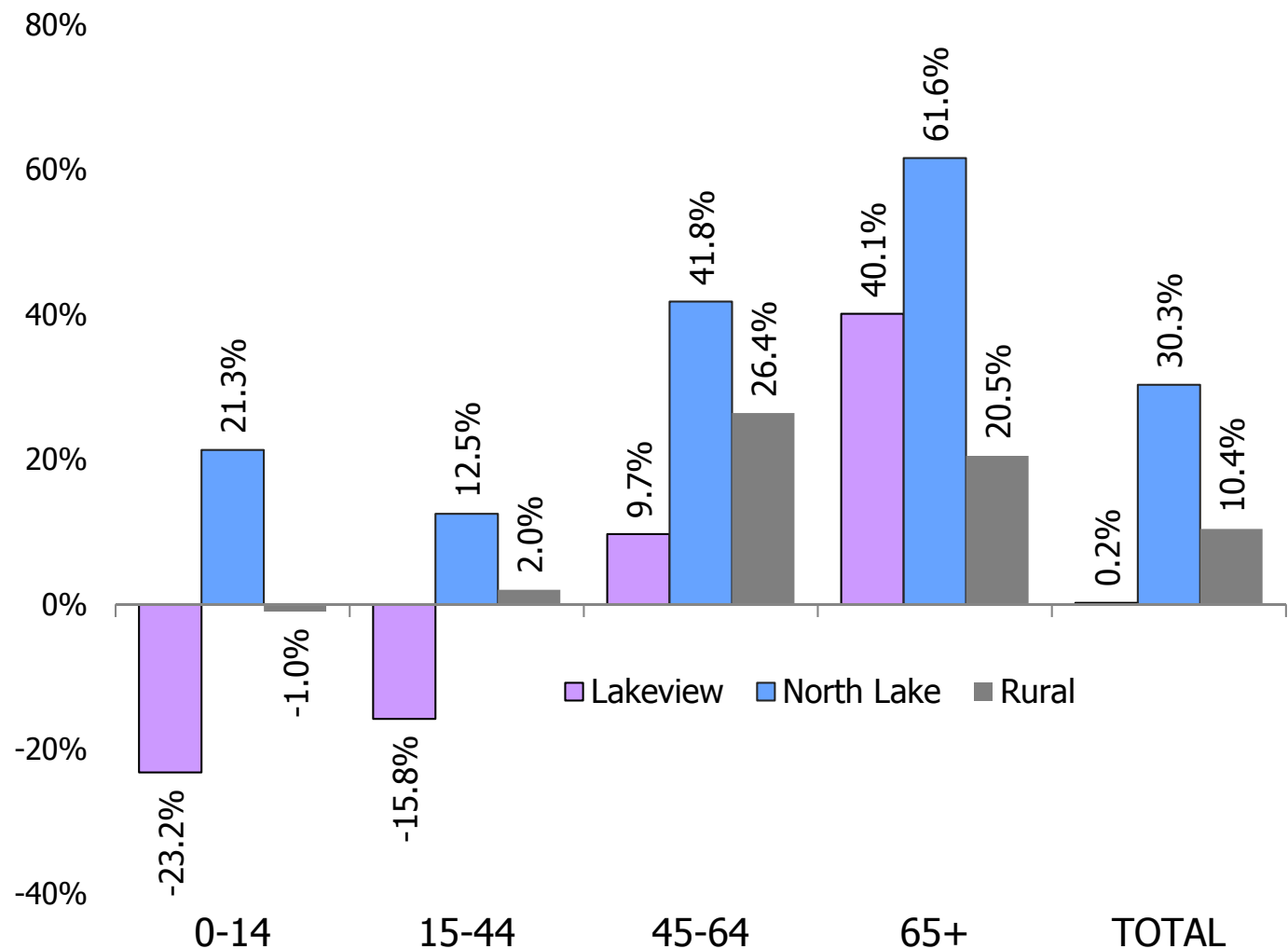

Service Area Percent Change by Age Breakdown (2000-2012)



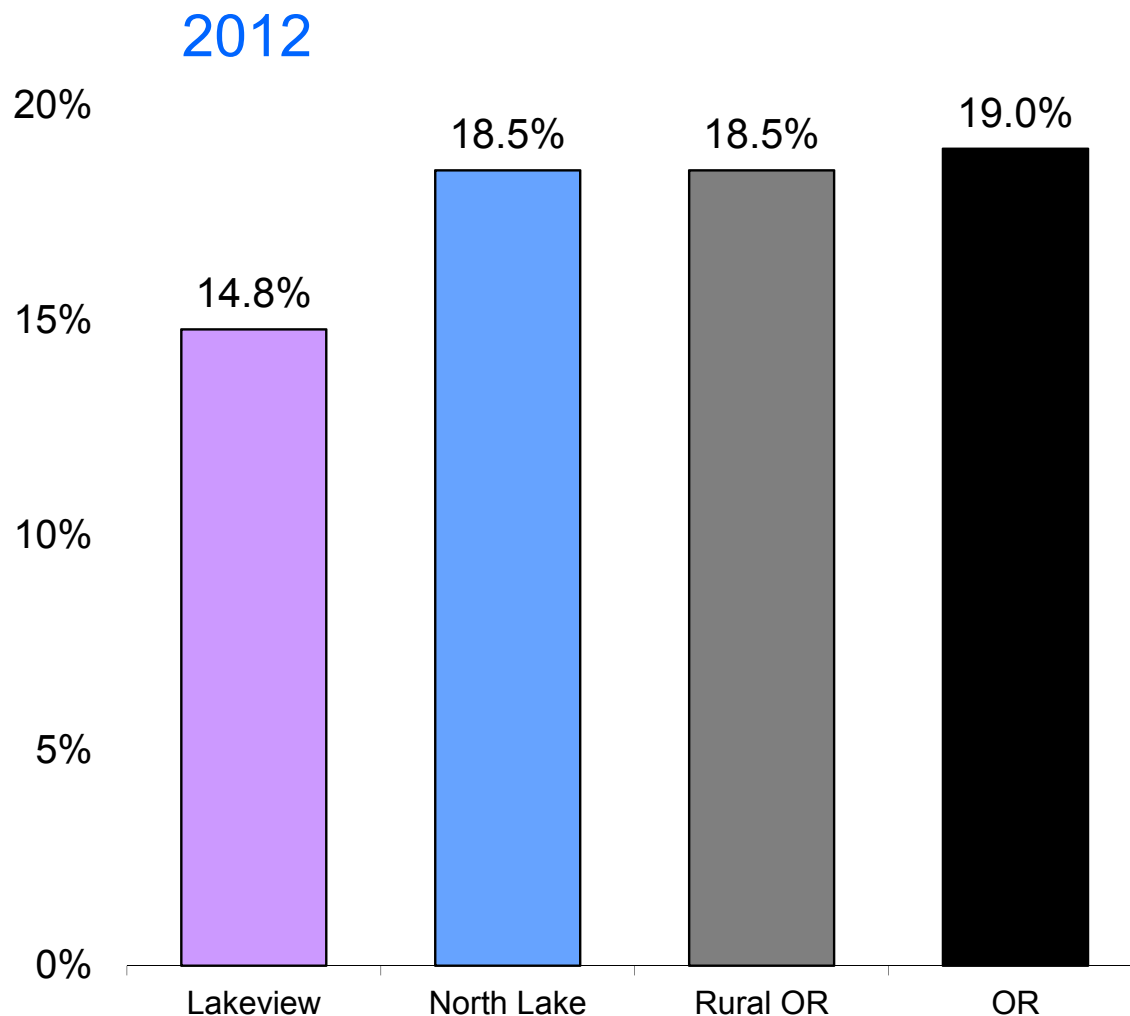

Percentage of Population Age <15

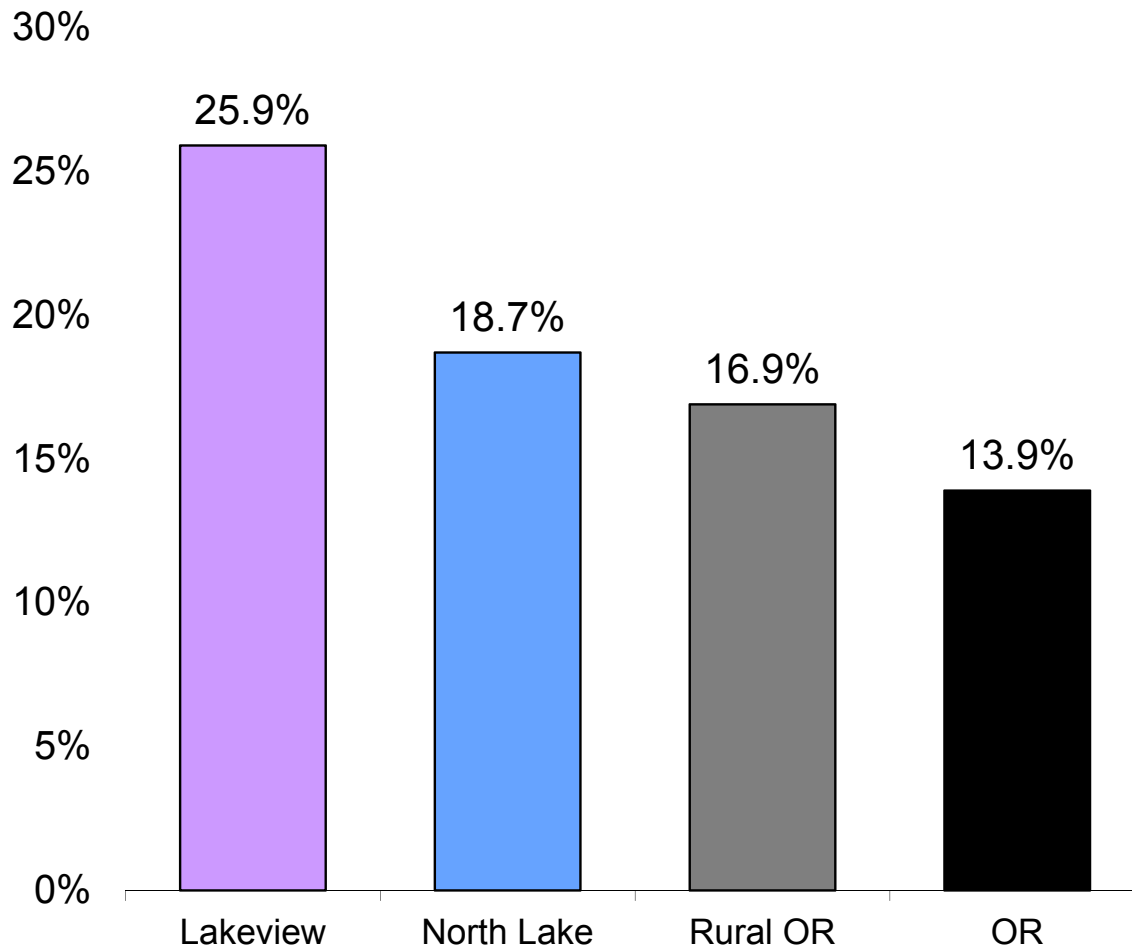


- High percentages in this age group many times means more obstetrical work and lower inpatient rates. This age group is not a big consumer of health services. However, they are the target for health education/prevention information.

Percentage of Population Age 65+

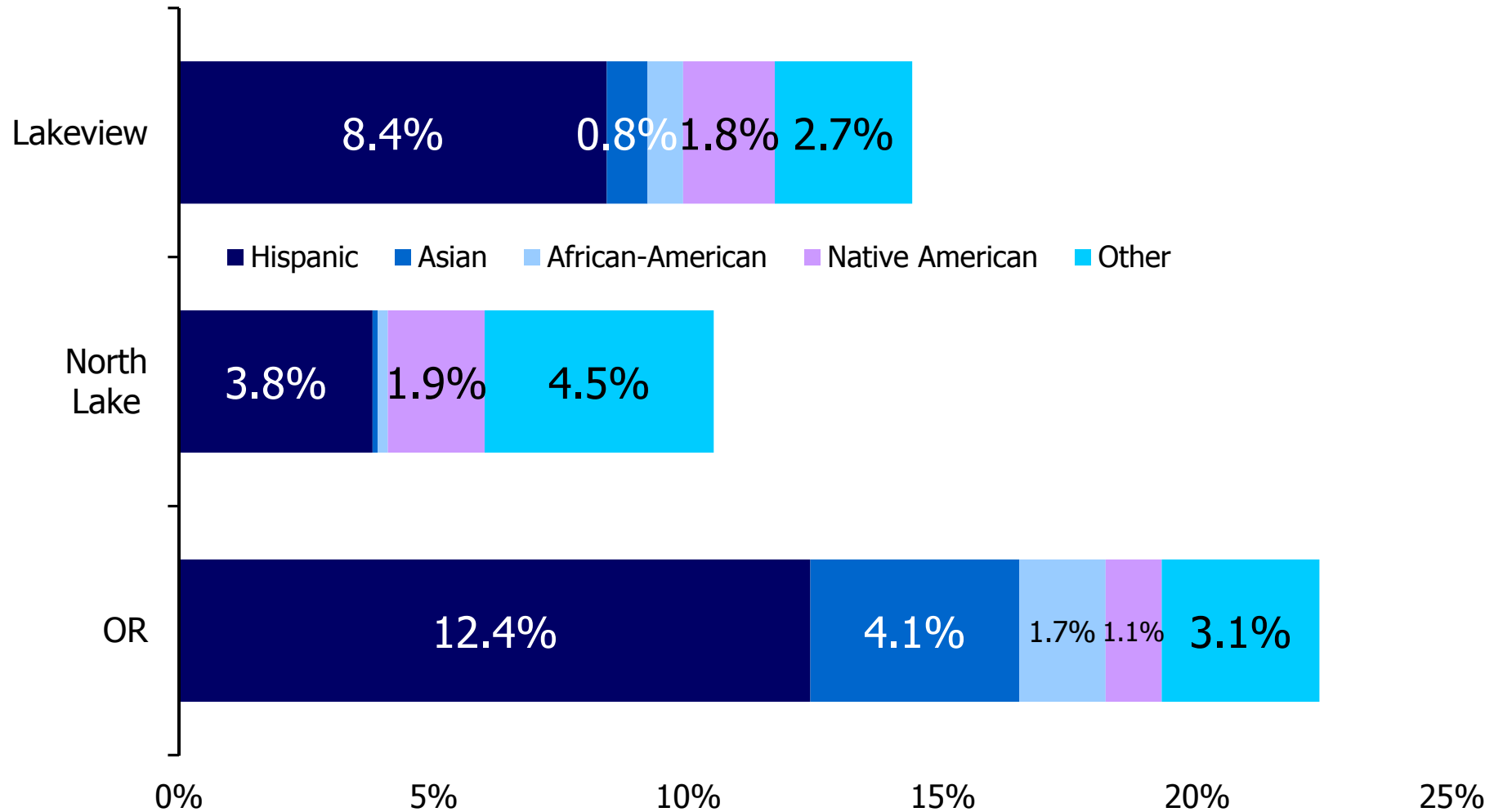

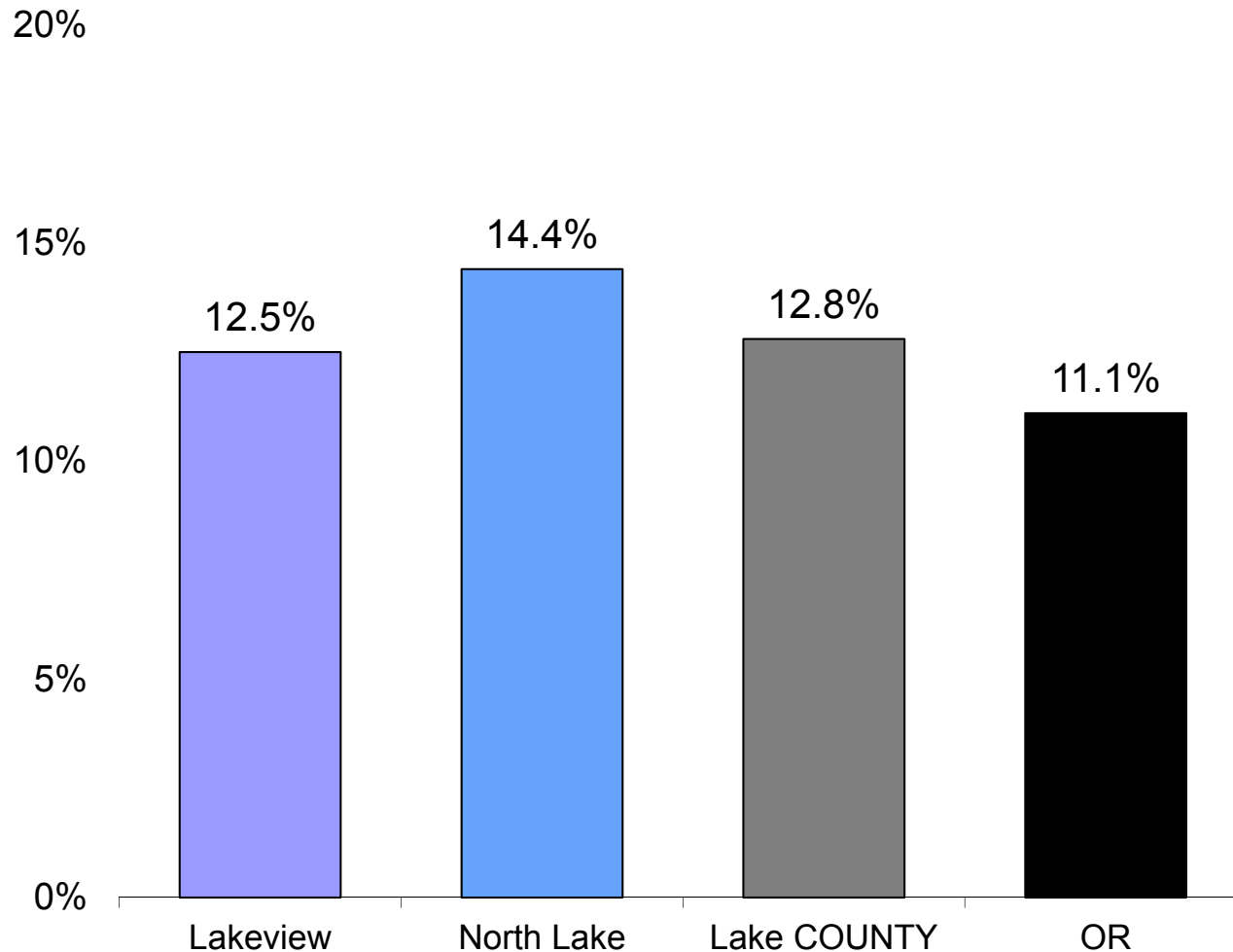


- People age 65+ are entitled to health coverage from **Medicare**. High dependence on Medicare as a source of payment to a health provider is not a good indicator.
- Over 50% of Oregon primary care physicians do not currently accept Medicare patients or they limit acceptance of Medicare patients.

Percent 25 and Over with no High School Diploma

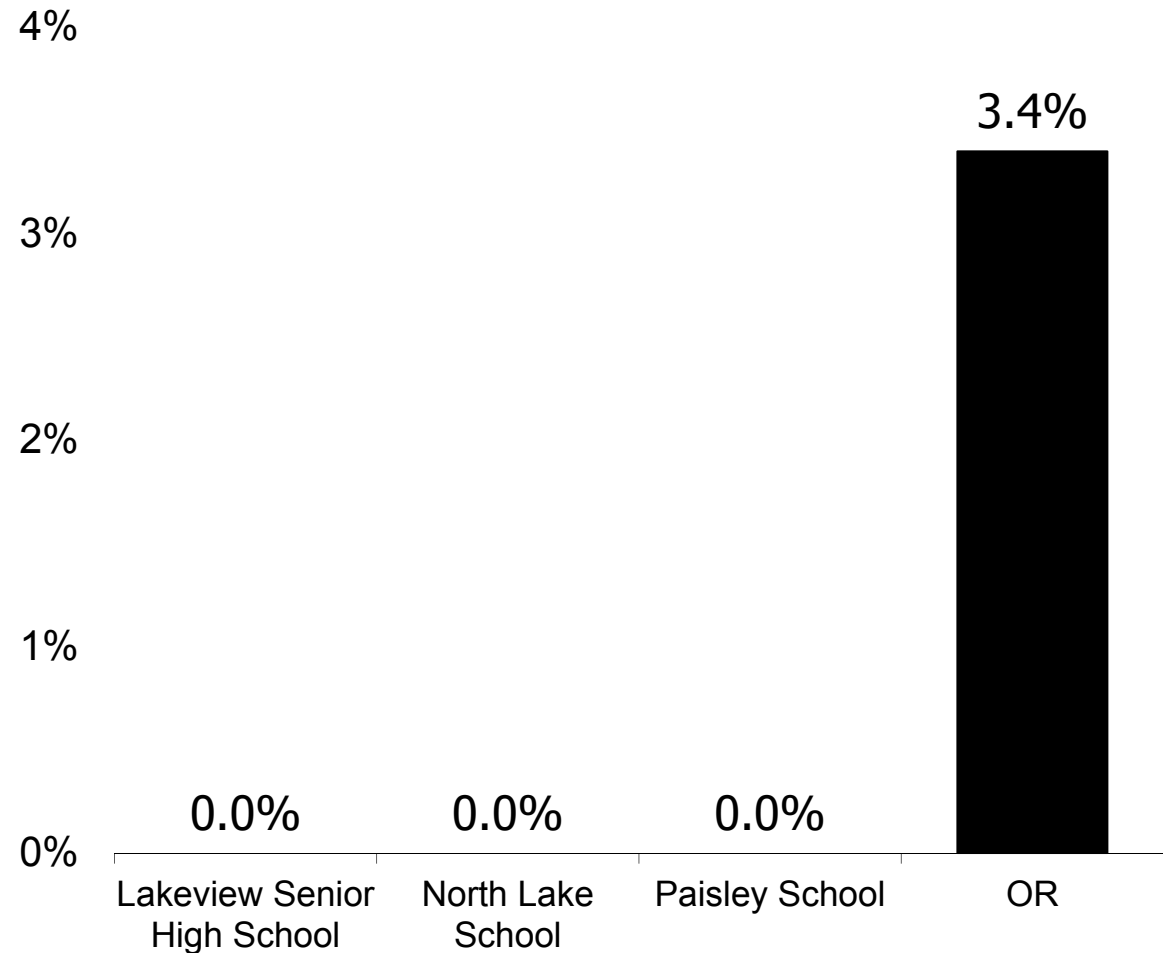


- Health information and education materials should be designed to meet the reading and thinking skill levels of consumers

Consequences of Dropping Out

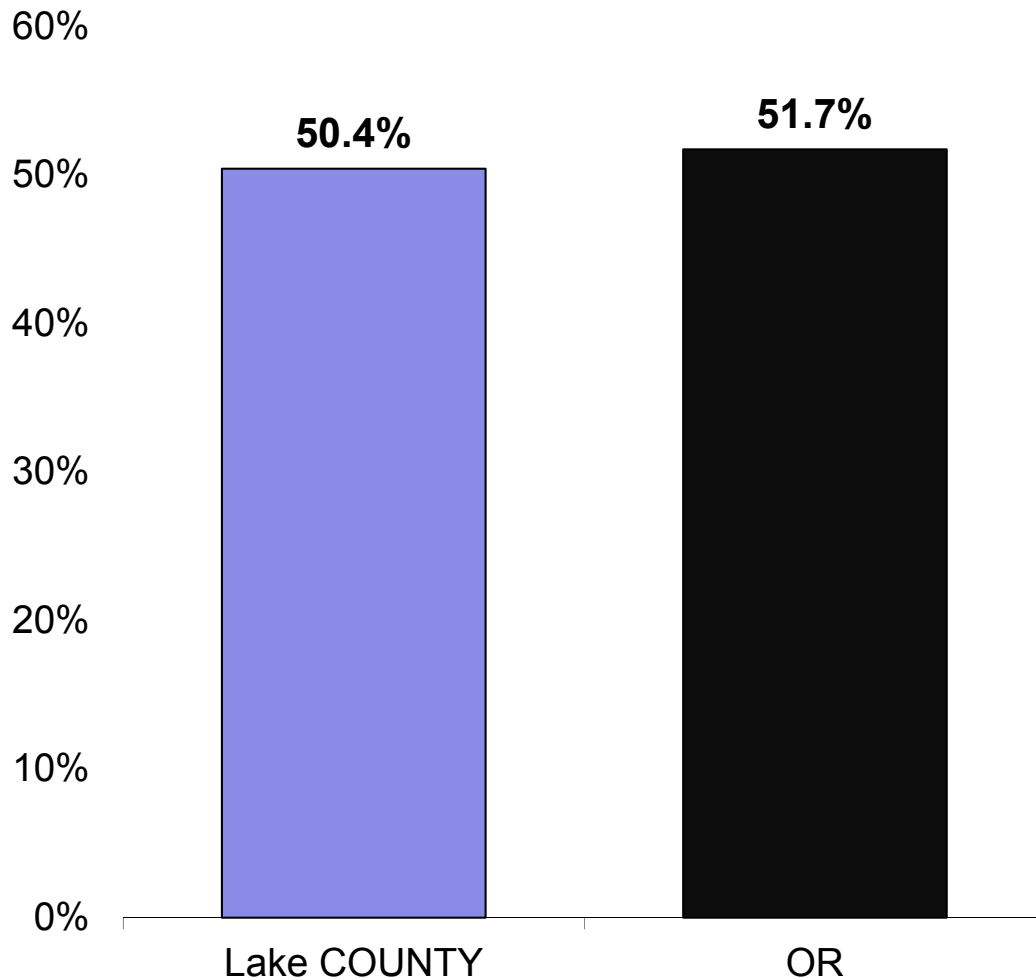
- Oregon high school dropouts...
 - Comprise at least 79% of the Oregon adult prison population at time of incarceration¹
 - Are four times as likely to be covered by the Oregon Health Plan, as are persons with at least a high school diploma²
 - Are more than twice as likely to be unemployed than students who graduate³
 - Are earning 30% less in wages than students who graduate³

Percent of Students Eligible for Free and Reduced Lunch (2011-12)

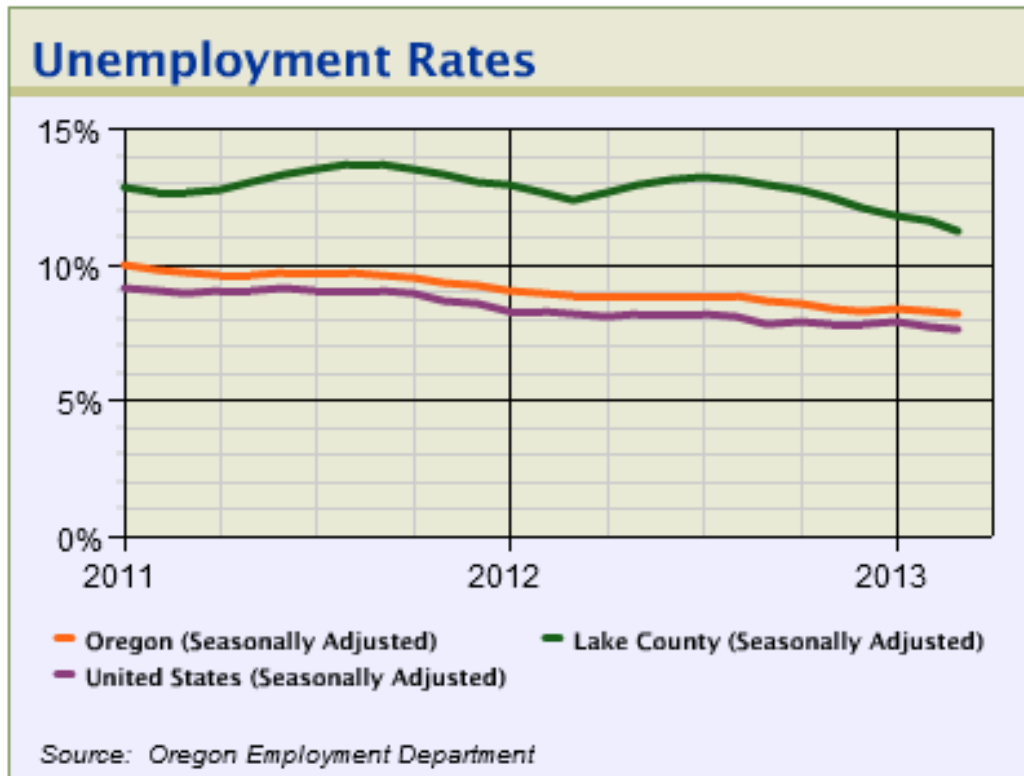


- Free and Reduced Lunch recipients are an indicator of at risk populations

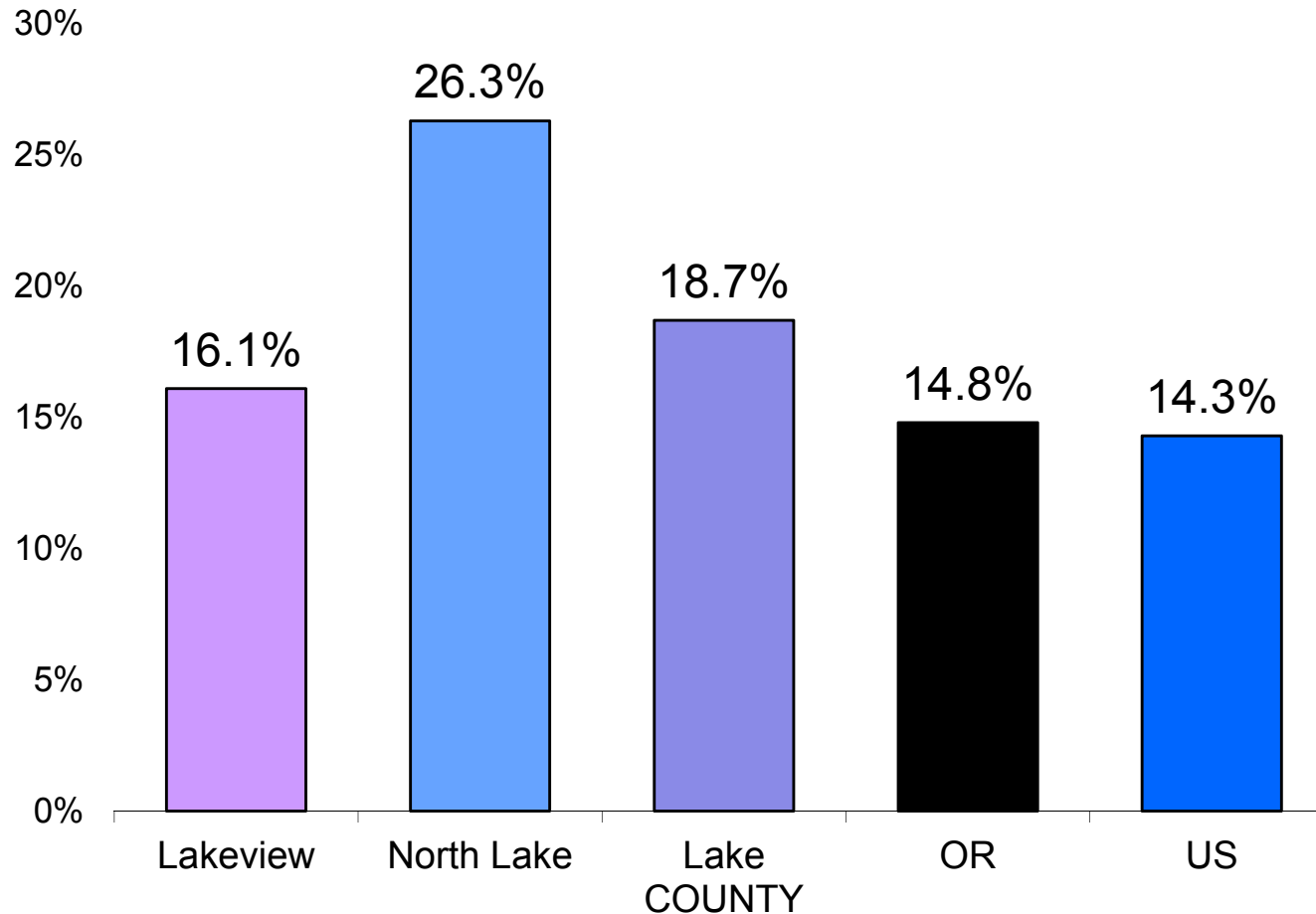
Unemployment Rates (2011-13)



- High unemployment rates reflect a less diversified economic base and vulnerability to economic fluctuations. Beyond the obvious financial burden of unemployment, people without jobs have even greater difficulty accessing health care because of lack of insurance or other means to pay.

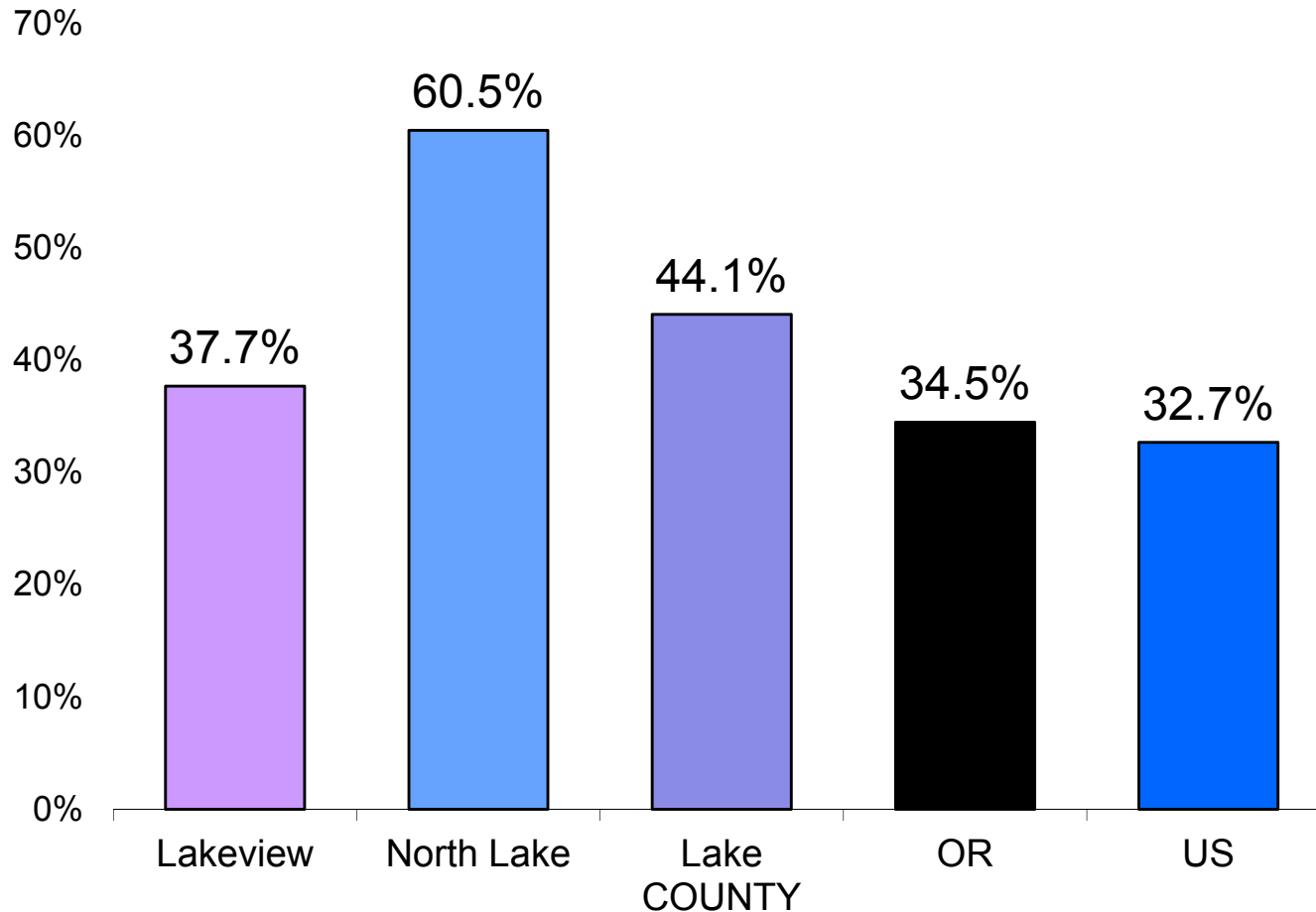


Percent Below Poverty Level 2007-2011



- The poverty threshold in 2012 for a family of 3 with one child is \$19,090 a year.

Percent Below 200% of Poverty Level 2007-2011

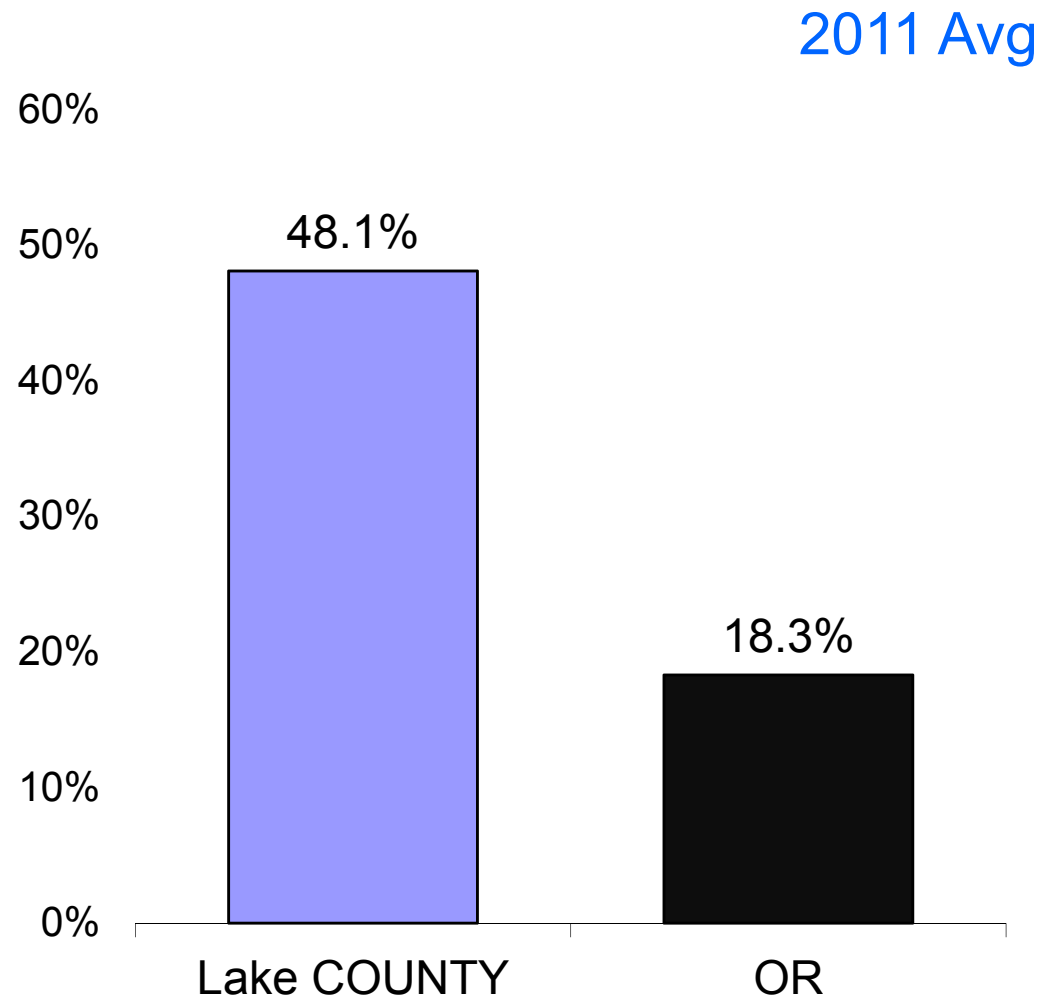


- For 2012, 200% of the poverty threshold for a family of 3 w/one child is \$38,180 a year. These are considered to be the “working poor”.

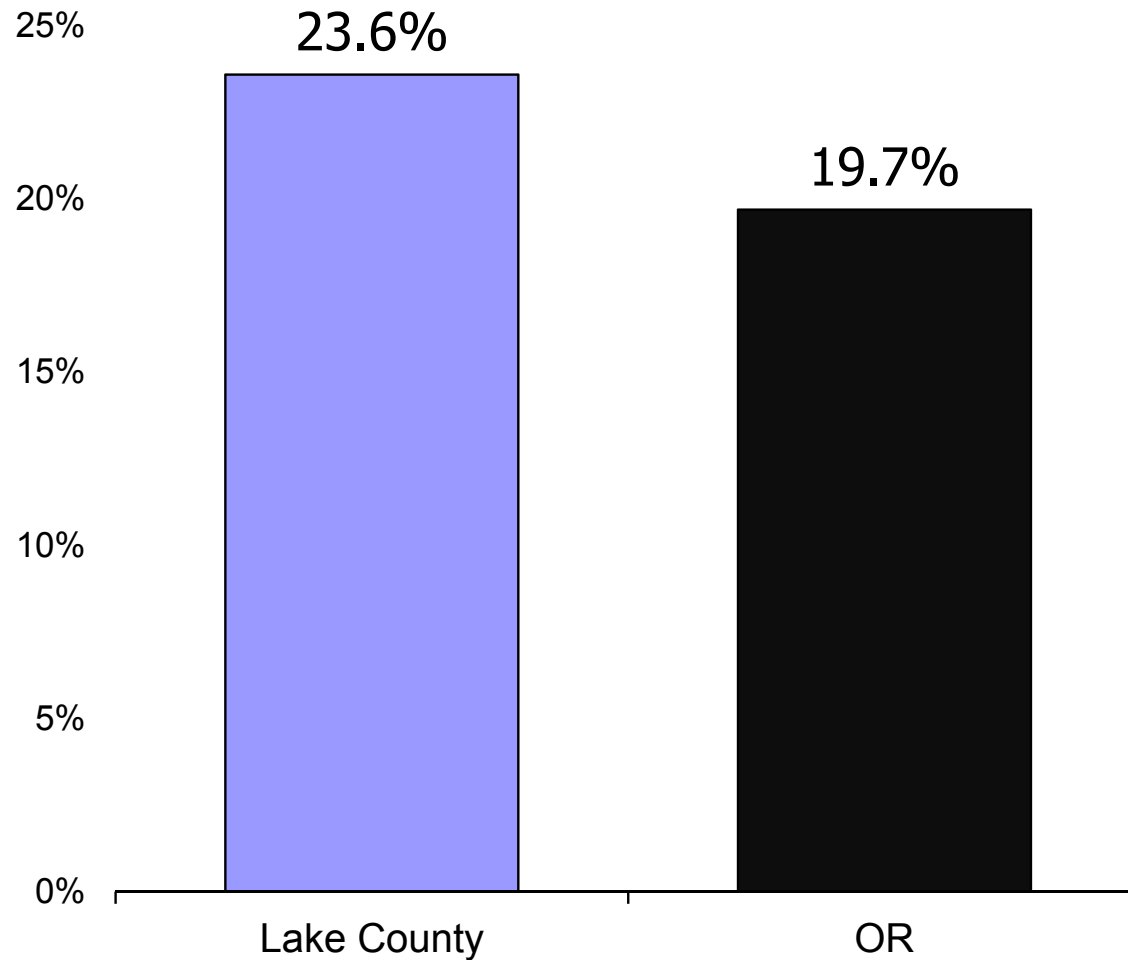
Government Employment as a Percentage of Total Employment



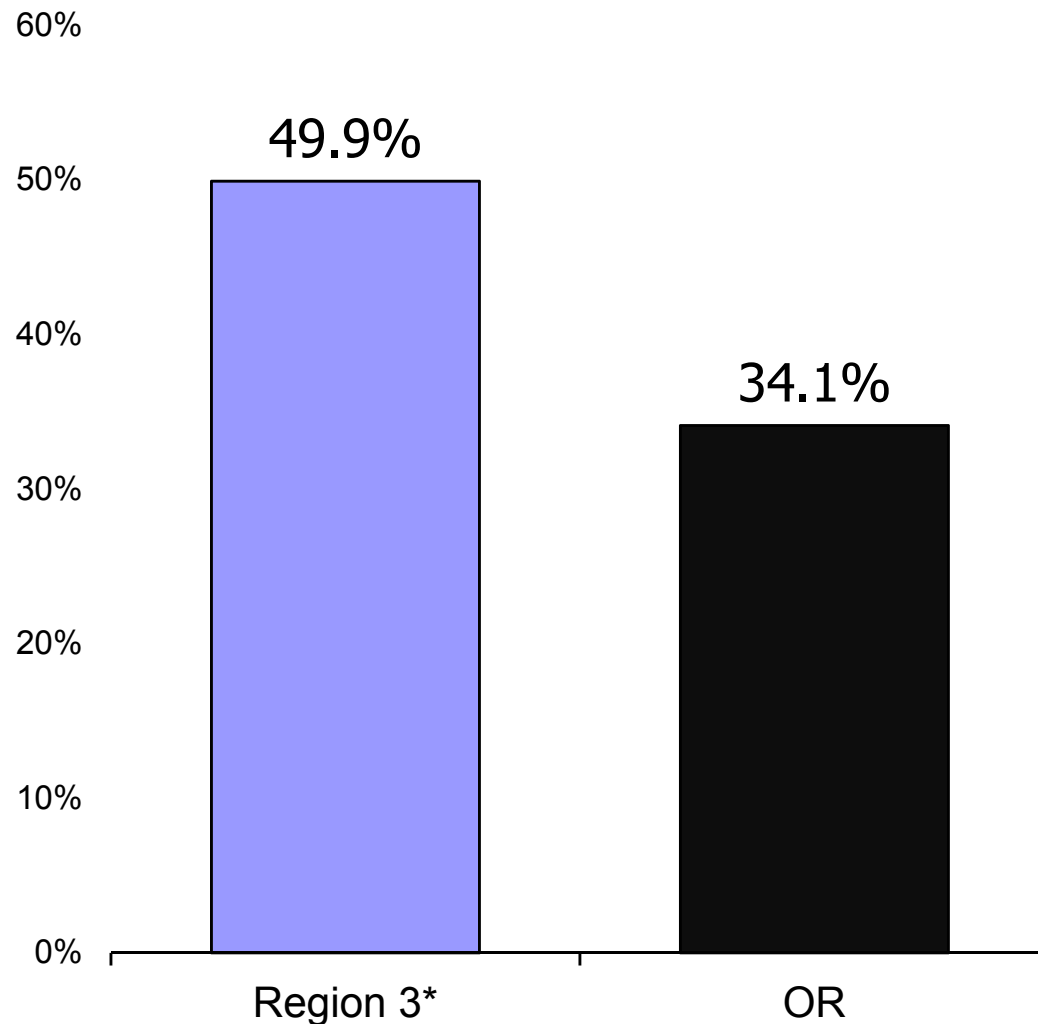
- Because everyone pays for the wages and benefits of government employees through taxes, this data MAY be used to encourage greater use of local health services by local government employees.

Percent of Individuals without Dental Insurance 2011



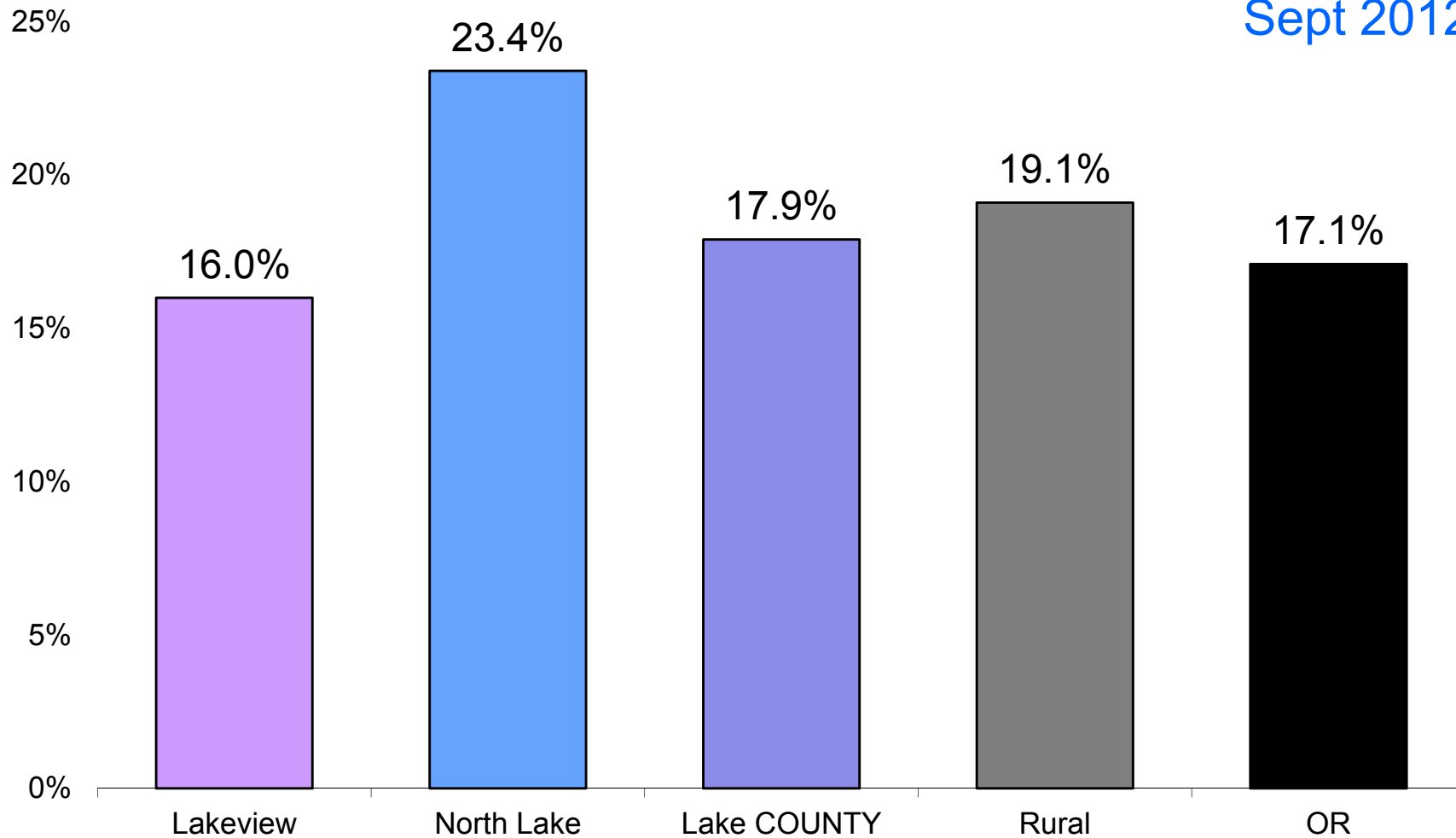
- Dental Caries is the most common chronic childhood disease and primarily affects low-income children

Medicaid Eligible as Percentage of Population



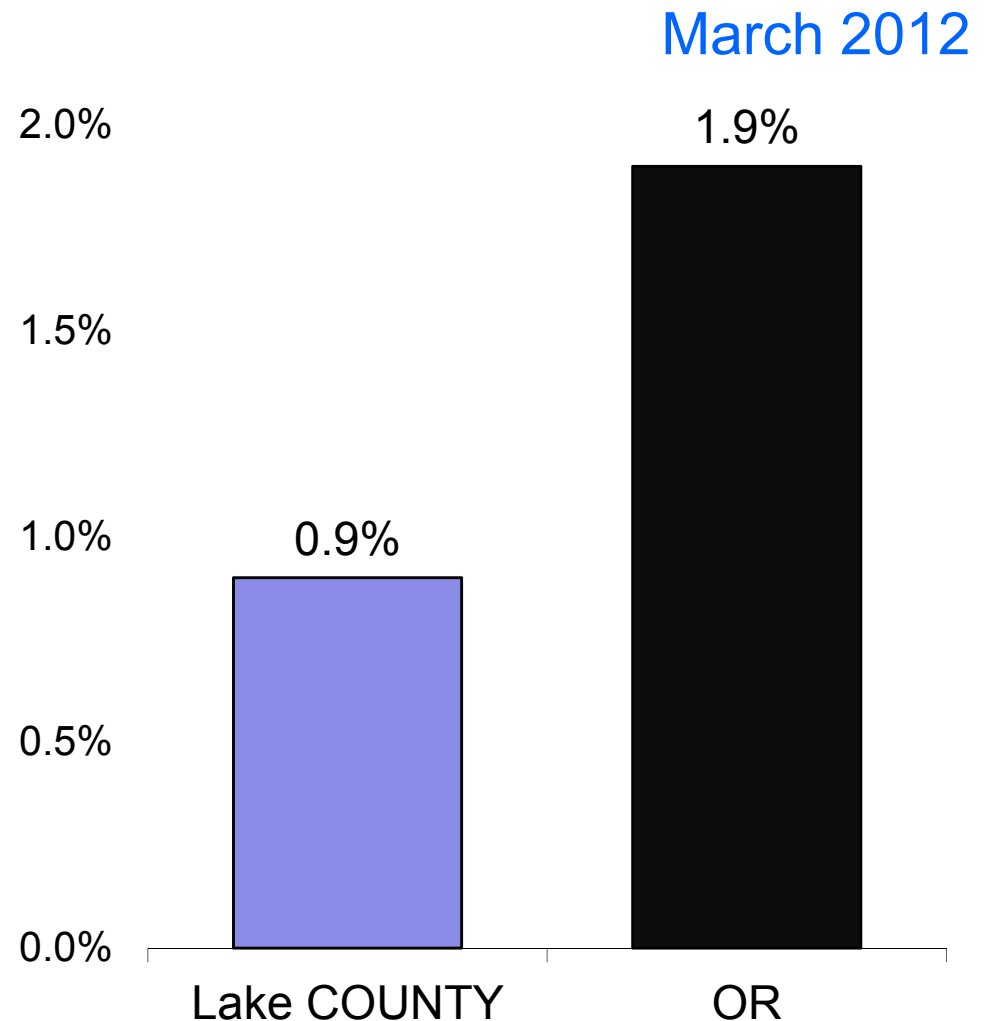

Temporary Assistance to Needy Families (TANF) Participants as % of Population



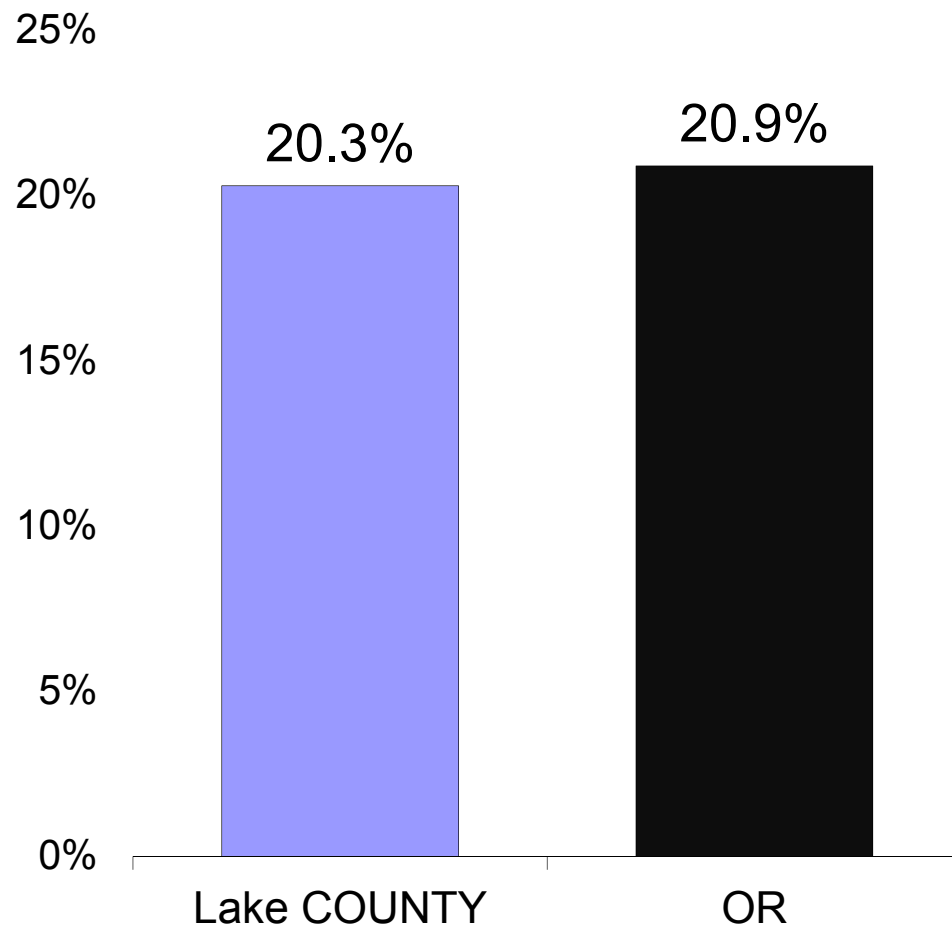
- TANF is the new name for Aid to Families with Dependent Children (AFDC). It is more popularly known as “welfare”.



Food Stamp Participants as a Percentage of Total Population

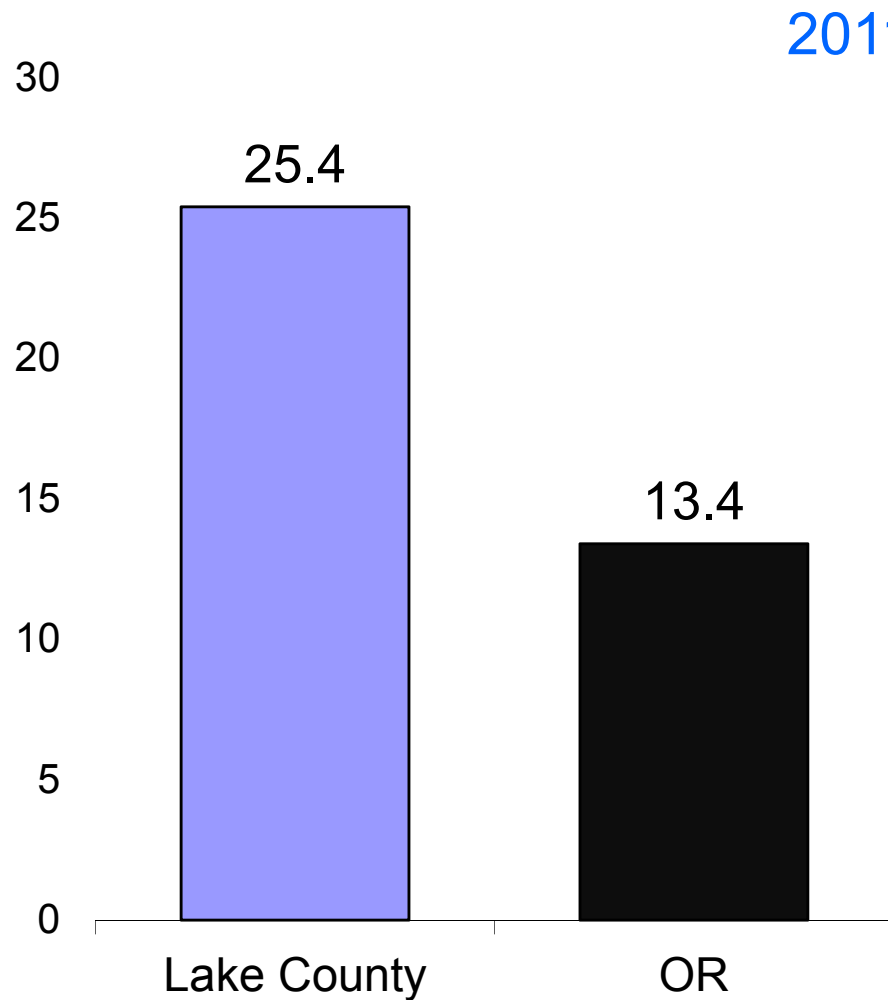
