TRAJECTORY OF ADVERSE EVENTS AND ANALGESIA WITH OPIOIDS IN OLDER ADULTS (TAANGO)

Topic: Study on the feasibility of developing and following a cohort of patients having chronic pain but not yet on opioid therapy. Subjects will be contacted every three months to assess new prescriptions and adverse events.

EMERGENCY DEPARTMENT VISITS FOR NON-TRAUMATIC DENTAL PROBLEMS IN OREGON STATE

Topic: This mixed-methods study will describe ED visits for non-traumatic dental problems, including predictors and costs, leading to potential solutions to reduce ED use for dental problems. We will collect claims data and conduct key informant interviews to gain and understanding of this issue.

CANCER RESEARCH TO OPTIMIZE SCREENING SUCCESS FOR RURAL OREGON ADULTS WITH DISABILITIES (CROSSROAD II)

Settings: Eight clinics, TBD

Topic: Create a partnership between rural primary care clinics and community-based organizations that advocate for people with disabilities. The project will deliver and test interventions to clinics and patients and will increase awareness for women eligible to receive cancer screening services.

CLINICIAN PERCEPTIONS OF AGING SERVICES TECHNOLOGY (CPAST)
