

# MGT 563 Regulation and Legislation in Healthcare

## Spring 2017 Syllabus

<b>Course Description</b>	This course reviews how governmental and non-governmental organizations influence health care delivery. Special emphasis is placed on current regulatory and legislative initiatives. Participants gain an increased understanding of the federal and state regulatory/reporting framework within which healthcare is delivered and the role of accreditation bodies within that framework. The course provides examples of the evolution of new legislative initiatives, both at the federal and state level, in order to demonstrate the complexity and impact of regulatory oversight on healthcare delivery. Guest lecturers provide the perspectives of experienced authorities in legislative and legal areas of healthcare and government..

**Course Objectives**

Upon successful completion of this course, students will:

- Understand the structure of the American legal system, its application to our healthcare system and gain insights on how federal healthcare policy is made.
- Recognize how rights and responsibilities of patients, providers, and health plans (both government and commercial) are described in contracts and federal and state laws.
- Appreciate general rules, and exceptions to those rules, related to the creation and operation of healthcare facilities.
- Understand the range of patients' rights and how those are expressed in formal, binding documents and interpreted by the courts.
- Understand legal principles associated with contracts, antitrust law, behavioral health law, intellectual property, bioethics, clinical research and reproductive rights.
- Be able to apply all of these in the student's managerial practice.

## Forums

The purpose of the forums in the Sakai Collaborative Learning Environment is to deepen your learning by applying what you read and view to the prompts provided by your instructors. The forums will also be used to assess your level of understanding of the topics presented in the text, readings, and videos for the week.

To facilitate meaningful discussion and engage a team dynamic, you have been assigned to a team for the duration of the course. Please read the Forum discussion question for the week and post your responses to your team thread. We encourage you to read the other teams' conversations. All Sakai postings must be in clear, concise, professional business language. The forums will proceed in the following general order:

- Each discussion will start with a prompt on Monday morning. Look for these as an announcement and in your team's forum. We advise you to read the forum prompt prior to reading the text and articles for the week as this will help focus your reading.
- Your instructors will check in on the forums frequently and add to the discussion to encourage deeper thought or get things back on course.
- We truly value your participation in these forums. They are 40% of your grade and the quality of your participation will determine your grade. Don't just post a "drive-by" post. Put some thought into your responses and really help further the discussion.

We will be accessing the timeliness and quality of your posts, the types of questions that you ask in the forums, how you answer other team members' questions, and how you further the conversation in the forums.

A total of **10 points** may be awarded each week using the following rubric:

**Did the student participate on time with quality responses that indicate an understanding of the week's text, readings, and videos and the ability to apply them to their own organizational or personal situation?**

All Sakai postings must be in clear, concise, professional business language.

- **5 points** for the quality and timeliness of your response to the initial prompt - **Due by 11:55pm Wednesday**
- **5 points** for furthering the group's discussion within the forum: **Due by 11:55pm on Sunday**  
How well did you further the discussion in your team's forum? Did you ask and answer questions that furthered everyone's learning? Did you bring new information into the forum? Did you apply this week's topic to your own organization or situation?
