BOOST III INFO

- ✓ **Survey:** All participating sites should have received the BOOST III Monitoring Equipment Survey last week. **This is due 12/4.** [Click here](#) to complete the survey if you have not done so. If you did not receive the e-mail, please contact Jenny Cook!
- ✓ **Contracts:** OHSU received the BOOST contract on 11/26. All “Hubs” should have their contract by 12/7. Hub contract questions should be directed to [Valerie Stevenson](#). If you are a spoke in our network, your contract will come through OHSU, and we are actively working on drafting your subcontract.
- ✓ **Site preparation:** If your site was not a regular user of the Licox monitor, you must demonstrate successful placement of 3 Licox monitors prior to being released to enroll. To demonstrate success, you will need to submit the following:
 - Head CT confirming placement
 - Brief patient Hx (eg 24yo F post MVC with GCS of 6)
 - The goal of demonstrating successful placement of these monitors is to give all staff familiarity with using them. Experience with the monitors is needed from all bedside providers – the MDs, RNs, APPs, RTs, etc. You do not have to use them to guide therapy, but the team needs experience with managing them and how to do physiological challenges.
- ✓ **BOOST investigator meeting:** Mar 19-20, 2019 – Atlanta, GA

- Plan to: Arrive on 3/18. Meet all day on 3/19, dinner will be on your own that evening, 3/20 will be part-day meeting, so attendees can fly home that evening.
