

# 1,102 Graduate from OHSU in June

Two separate graduation ceremonies for OHSU occurred on June 4 at the Arlene Schnitzer Concert Hall, Portland and two additional ceremonies were held on June 15, one in Portland and the other in Corvallis. A total of 1,102 degrees were awarded to students in health care programs at OHSU.

"One of the reasons that I, and so many of our faculty members, choose to work at an academic health center like OHSU is the chance to interact with students, to see their enthusiasm and their idealism..." OHSU President Joe Robertson M.D., M.B.A, said. "... it is a special day when we send new graduates out into the world to be health care providers, educators and research scientists to improve the health and well-being of Oregonians."

In the School of Medicine's commencement ceremonies June 4, a total of 533 diplomas and certificates were awarded. School of Medicine Dean, Mark Richardson, M.D., M.B.A., M.Sc.B., said "The OHSU School of Medicine takes pride in preparing our graduates to be leaders in the fields of health care and bioscience. One-third of all practicing physicians in the state received all or part of their training at OHSU – a demonstration of our impact on work force needs and our graduates' commitment to serving Oregon."

Doctor of Medicine diplomas were awarded to 121 students, making it one of the largest M.D. classes in the past 10 years. In addition, 40 Ph.D. degrees were awarded, as well as 172 master's degrees; 11 "combined" (M.D./M.P.H., and M.D./Ph.D.) degrees; 28 associate's degrees, 35 bachelor's de-

grees, and 126 graduate certificates.

In the School of Nursing's ceremonies a total of 396 diplomas were awarded by Interim Dean Chris Tanner, RN., Ph.D., F.A.A. N., Youmans Spaulding Distinguished Professor. Three hundred and two bachelor's degrees were awarded along with 54 master's degrees, 7 Graduate Certificates in Public Health, 1 post-master's certificate, 11 doctor of nursing practice degrees and 5 Ph.D.s. "This is a time of great change for nursing and health care, and nursing is positioned to lead the way," Dr. Tanner said. "Our voices have never before been so important."

The School of Nursing has more than 1,000 students enrolled in its undergraduate and graduate programs at the main (OHSU) campus and across the state.

The School of Dentistry's graduation was on June 15 with a total of 90 degrees awarded: 74 Doctor of Dental Medicine and 16 Advanced Specialty degrees in the fields of endodontology, oral and maxillofacial surgery, pediatric dentistry, periodontology and orthodontics. "It is very difficult to get into dental school and it is even harder to get out," Interim Dean Gary Chiodo, D.M.D. F.A.C.D., said. "Our new graduates have worked hard and these are highly accomplished health professionals who join our ranks."

Graduation ceremonies for the OSU/OHSU College of Pharmacy were June 15 in Corvallis with 84 students in this program receiving the Pharm.D. degree.

Proceeds from the sale of the book support activities of the Marquam Hill Art Committee and its mission to acquire and curate art and advance appreciation of OHSU's extraordinary art collection.

In April, OHSU reported that it has signed on to collaboration between Portland-area health care entities, symbolized with a letter of intent to form a Coordinated Care Organization for Oregon Health Plan (Medicaid) members. The letter was submitted to the Oregon Health Authority, which is poised to begin certifying CCOs after July 1.

The letter of intent was signed on behalf of the Tri-County Medicaid Collaborative, a group of 14 health care organizations in Clackamas, Multnomah and Washington counties who have been meeting for months to address "a single, complicated question: Can we together improve the quality of care and the care experience of Oregon Health Plan members, and do it for less money?"

Two central components of the discussion, involving top OHSU executives including OHSU President, Joe Robertson, M.D., M.B.A., are the anticipated increase in Medicaid patients as a result of federal reform, and the nation's aging population. While there are many details to be worked out, Peter Rapp, OHSU Executive Vice President and Executive Director, OHSU Healthcare, noted the unusual engagement of all the large stakeholders – including Legacy, Providence and Kaiser.

The tri-county Coordinated Care Organization could be a model for the rest of the country as states grapple with developing systems of care that are coordinated, effective and less expensive, according to Mr. Rapp.

#### DOERNBECHER HOSPTAL RANKS HIGH

Doernbecher Children's Hospital ranks among the best children's hospitals in the country, according to *U.S.*News & World Report's 2012-2013 Best Children's Hospitals. The rankings, reported in June, are based on quality-related data, including survival rates, adequacy of nurse staffing and procedure volume and, to a lesser degree, peer-to-peer rankings. For the 2012-2013 rankings, *U.S. News* surveyed 178 pediatric centers to obtain hard data. This data comprised 75 per cent of the rankings. In a separate reputational survey, 1,500 pediatric specialists were asked where they would send the sickest children in their specialty, and their response made up the remaining 25 percent.

# **Educational Changes Anticipated When CSLB Opens in 2014**

Learning team skills by OHSU students was the subject of a June 15 front-page article in the Portland Business Journal. Excerpts from the piece follow.

"When OHSU moves into the \$295 million South Waterfront Collaborative Life Sciences Building in 2014, it will for the first time teach would-be physicians alongside other future medical professionals such as nurses and pharmacists.

"OHSU President Joe Robertson, M.D., M.B.A, and Provost Jenny Mladenovic, M.D. believe OHSU is launching the country's largest-scale inter-professional program. The School is also at the forefront of national efforts to offer more cross-medical training.

"It's a drastically different arrangement in that the 'interprofessional education' curricula encourages future doctors to work as team members with their medical peers. One point of friction in the physician work-force is that many have not been trained to work as a part of a team, Betsy Boyd-Flynn, Oregon Medical Association, said. 'They're trained to make autonomous decisions. But with health reform moving more toward team-based models, it only makes sense to change the education accordingly.'

"OHSU, the Life Sciences Building's primary tenant and funder, is moving most of its medical school programs to the new structure. Professors from OHSU and Oregon State University who will teach 115 third and fourth year pharmacy students at the Portland site are still devising ways to mix the different student.

"Currently doctors are trained in silos and we magically expect them to work together in the medical environment," Dr. Robertson said. 'By working together early on in their careers, doctors can improve patient outcomes. When there are poor outcomes, it's usually because people didn't communicate well, not because they didn't have the right training'.

"The cross-training could help physicians who plan to practice in Oregon's rural areas because such doctors typically require expertise in several areas. OHSU has lately pushed for more of its medical school graduates —once the Life Sciences Building opens, the school will graduate 160 a year — to practice outside of urban areas.'

"If OHSU succeeds in its inter-professional medical education efforts, the school would, according to the article, gain national credibility. "Construction is well underway for the new building. It will allow OHSU to increase its medical school class by 25 per cent annually.

"The Inter-professional strategy is a challenging undertaking. The Association of American Medical Colleges renewed a push for its members to adopt interprofessional curricula after halting a previous attempt in 2001. The group cited such challenges as difference in academic cultures, language and jargon, schedules, clinical responsibility and qualification levels.

"Dr. Mladenovic believes OHSU's efforts have at least one advantage. The new Life Sciences building is large enough (480,000 square feet) to accommodate programs for future doctors, dentists, nurses, pharmacists, physician assistants, radiation technologists and biomedical researchers.

"OHSU and its academic partners will also synchronize their academic calendars so that classes for all the groups of students will begin at the same time in 2014.

"Portland State University, which will provide biology and chemistry classes and laboratory services in the building, backs the inter-professional efforts, according to Roy Koch, provost.

"Dr. Mladenovic said more than 100 OHSU faculty members are working on the medical school's transition. "It won't be easy: You only have to be a dean once to understand how challenging it is to change a curriculum," she said. 'But we've always had leaders who believe we can do things better."

#### INAUGURAL RESEARCH WEEK

For four days during OHSU's inaugural Research Week, May 7-10, more than 300 investigators from all corners of the campus, shared projects through oral presentations and poster sessions to stimulate questions and new lines of thinking and to connect with one another. The commitment to share research extended well beyond the labs on Marquam Hill – many students from the College of Pharmacy drove up from Corvallis to present their work. Three well- attended "keynote" talks were included during Research Week: Nora Disis, M.D., Professor of Medicine, University of Washington; Mary Woolley, President and CEO of Research America; and Darlene Francis Ph.D., assistant professor of public health and neuroscience, University of California, Berkeley all spoke.

# "Unlocking Value" Initiative

On February 12 School of Medicine Dean Mark Richardson, M.D., M.B.A., M.Sc.B. spoke about the goal of this "Unlocking Value" initiative: to generate new revenue by investing and allocating resources in research areas with commercial potential. This new revenue will, over time, he said, help support School of Medicine scientific, education and other faculty initiatives through re-investment.

In the School of Medicine, this initiative has taken form with the development of a "Research Roadmap", by a group of about 100 faculty members and headed by Mary Stenzel-Poore, Ph.D., Senior Associate Dean for Research and Chair, Department of Molecular Biology and Immunology. The School of Medicine plan is incorporated in a multi-page booklet.

In the School of Dentistry, Interim Dean Gary Chiodo, D.M.D., F.A.C.D., used the occasion of the Dental School's fourth annual Research Day to comment on this issue. "It is exciting to see how developing scientists are doing groundbreaking work. Each School at the University is currently developing a 'Research Roadmap' to outline strategically their goals for research by 2016. Ours will emphasize the value of collaborative, interdisciplinary, translational research, which is the direction more funders are looking."

#### **VGTI Receives \$8 Million Grant**

Vaccine Development Researchers at OHSU's Vaccine and Gene Therapy Institute were awarded an \$8 million grant from the Bill & Melinda Gates Foundation to further develop a promising HIV vaccine candidate to combat the worldwide AIDS epidemic. The award was announced in January. According to the World Health Organization, more than 34 million people have contracted HIV worldwide and more than one-third of babies born in low- or middle-income countries already are infected. The research will build on previous research conducted by **Louis Picker, M.D.** and colleagues at the VGTI, according to the announcement.

## **OHSU Purchases Additional Land**

OHSU is planning to expand its presence in Portland's South Waterfront District at a future date based on the purchase of two parcels of land in the neighborhood. In May, the purchase of two blocks (4.5 acres) was finalized. The two parcels are located directly east of the Center for Health & Healing and south of the Ross Island Bridge. The total purchase price for the two parcels is \$13.6 million.

OHSU has no immediate plans for development on the parcels at this time, but it expects to construct new outpatient facilities on the land to both replace aging patient care areas on Marquam Hill and in response to expanded need.

"Despite the current slow economy, OHSU is pleased to continue to fuel job growth and economic development in the state," OHSU President Joe Robertson, M.D., M.B.A., said. "Since the depth of the recession in May 2009, OHSU has added more than 1,400 employees. This new investment in Portland South Waterfront District will also create future jobs for Oregonians."
