COURSE DESCRIPTION

2019 marks the 26^{th} Annual Internal Medicine Review, providing up-to-date clinical information and critical review of topics essential to internists and advanced practice providers.

In addition to Literature Reviews on Allergy and Hematology, plenary topics include menopause, supplements, insomnia, the aging brain, aspirin use and assessing radiating extremity pain. Each day has breakout sessions, allowing attendees to select talks most pertinent to their individual practices.

- Work with patients to create treatment options after a breast cancer diagnosis
