<p>Applicants must be enrolled in doctoral programs accredited by the <i>APA Commission on Accreditation</i> and be pursuing a doctoral degree in clinical, counseling, or school psychology. Further, they must be US citizens, hold a Permanent Residency Visa, or have a student visa with the intent to stay in the United States following completion of their doctoral degree.</p> <p>Applicants must have completed at least 3 years of graduate training in psychology, two of which must be in full-time residence at the institution that will be granting the doctoral degree. Applicants must have proposed their dissertation by the time of submitting ranking to the National Matching Service.</p> <p>We seek interns who have a strong background in at least one of the following areas: developmental disabilities, assessment of pediatric/child populations, pediatric psychology, pediatric chronic illness, and child and family cognitive behavioral/behavioral intervention. We seek applicants with training and experience in models of practice that focus on using empirical data and methods to select/evaluate assessment and intervention practices.</p>
