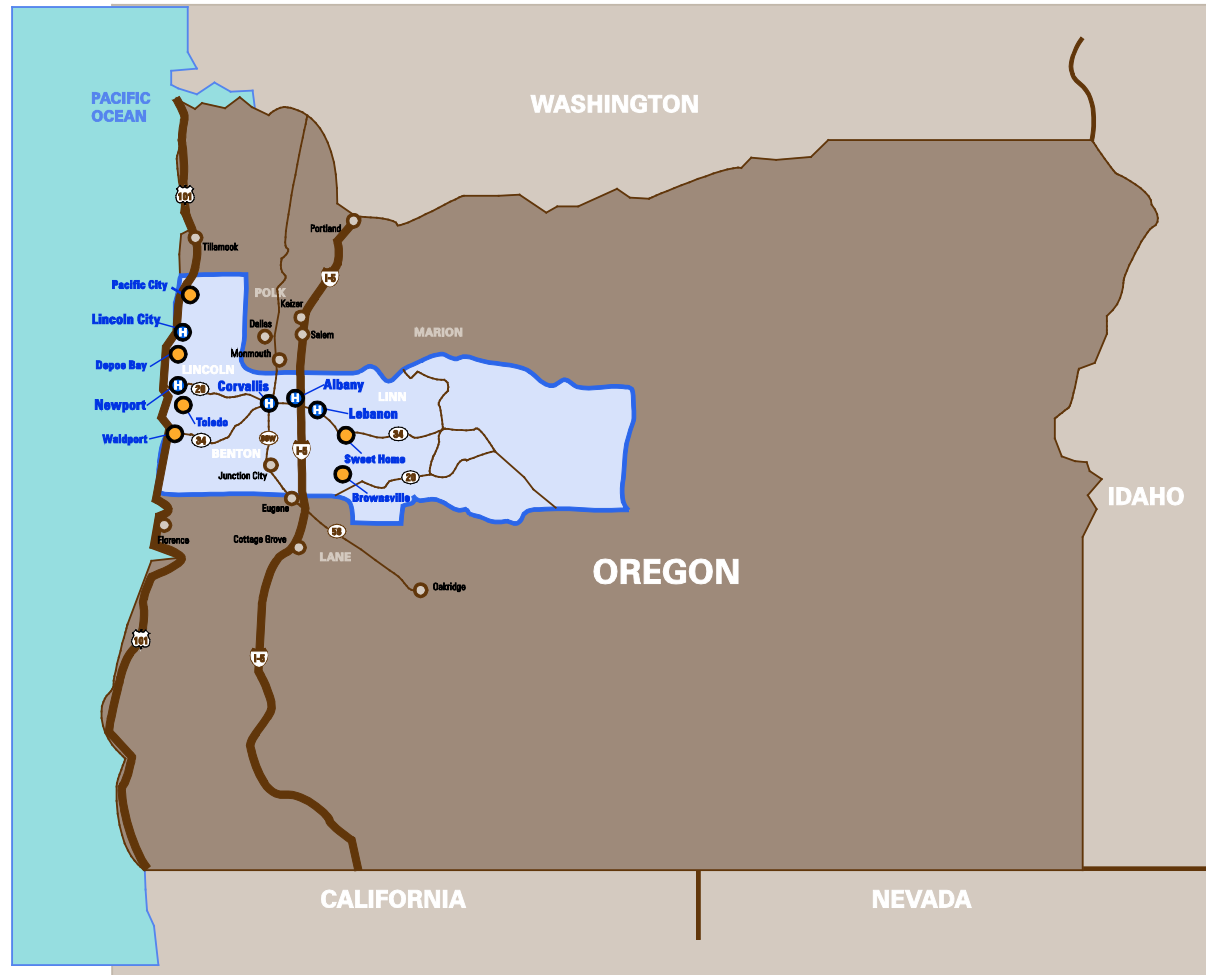

- 55 Health Care Leaders, Education, Community, Business, Government, Faith, Tribal

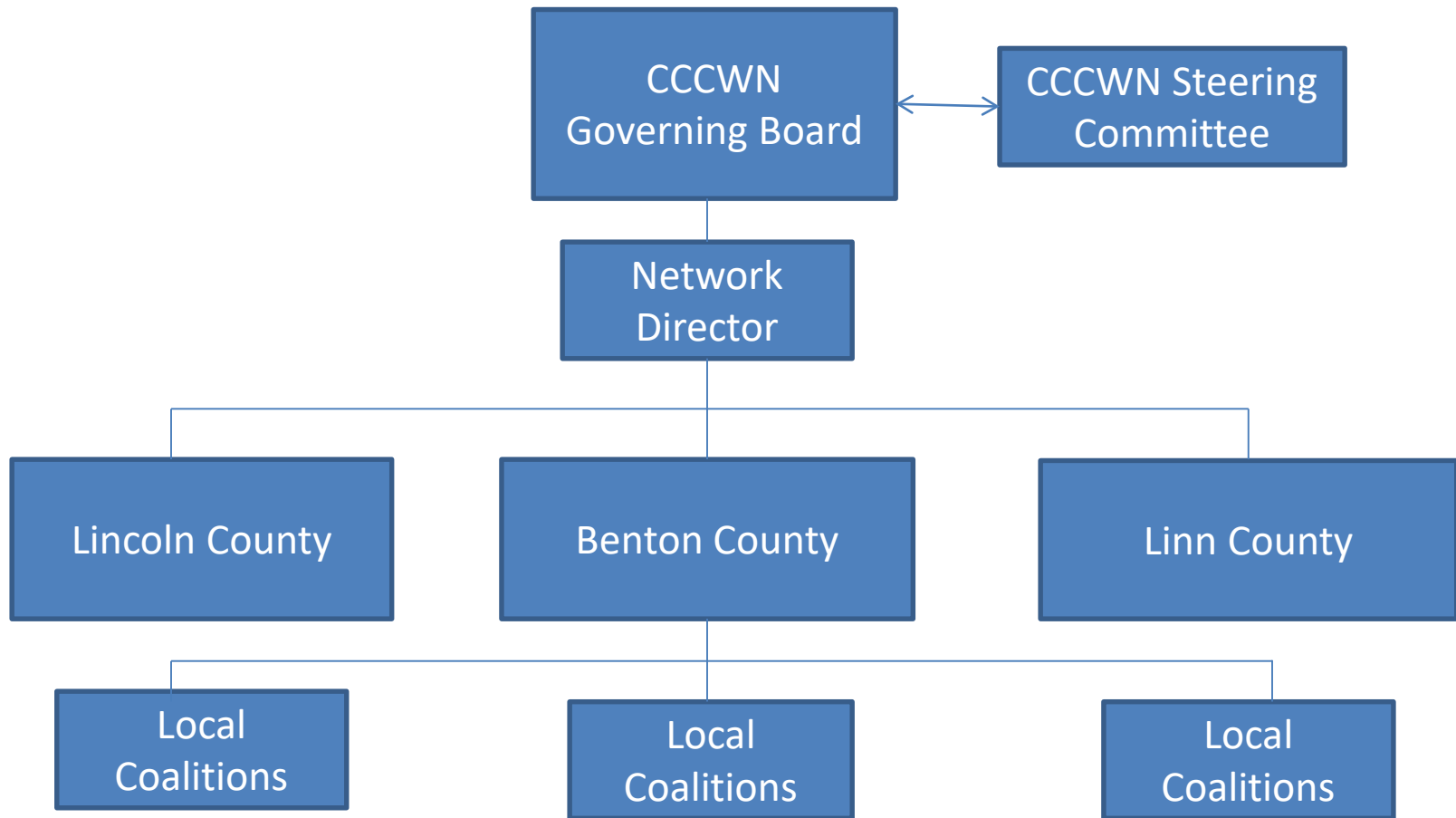
Coast to the Cascades Community Wellness Network (cont.)

MEMORANDUM OF AGREEMENT

THE COAST TO THE CASCADES COMMUNITY WELLNESS NETWORK-2012

This Memorandum of Agreement (MOA) is between Coast to the Cascades Community Wellness Network member organizations (hereinafter referred as the CCCWN) for the purpose of defining roles and responsibilities in current and future development of projects, initiatives and activities between the identified organizations.

The MOA may be amended to change the terms and agreement or to include additional representatives. This MOA may be terminated by any representative upon 30 calendar days written notice to the CCCWN staff.

A. Structure

The CCCWN membership is comprised of the following lead agencies and partners:

The development of a sustainable collaboration between CCCWN member organizations will ensure a coordinated and systemic effort to address health issues in Benton, Lincoln and Linn Counties. The knowledge, experience and expertise of each organization will result in improved coordination of efforts to address health issues in the tri-county region. The working relationship among the aforementioned organizations is formalized in this MOA for future endeavors and sustainability.

The CCCWN will function as the lead team comprised of representatives from each listed organization. The CCCWN will communicate on an on-going basis to identify key focus areas of health in the tri-county region.

B. Mission and Vision

The mission of the CCCWN is to provide leadership to enhance the health of communities through development and support for collaborative regional partnerships in Benton, Lincoln and Linn Counties.

The vision of the CCCWN is to lead and sustain a system of partnership agencies and organizations working together to provide integrated services and programs to promote individual and community health.

C. Responsibilities and Agreements

The overarching responsibility and agreement of the CCCWN is effective collaboration. The CCCWN member organizations agree to the following:

- Participate in meetings of the CCCWN
- Share in decision-making through consensus regarding issues that impact the CCCWN
- Develop, review and approve joint projects and publications that benefit the CCCWN
- Offer training, education, resource and information to the CCCWN member organizations
- Collaborate to develop new resources and funding that promote health in the tri-county region
- Receive regional data updates and reports on health issues
- Participate in discussions on data analysis
- Direct the CCCWN assigned staff on projects, activities and initiatives
- Provide direction and oversight of funding that support the CCCWN
- Ensure materials and publications developed for the CCCWN shall be available to all members

D. Financial Participation

Each party to this agreement will cover their own expense in performing work under this memorandum of agreement. Each party will expend its own funds in a manner congruent with their own mission and vision. Parties to this memorandum agree to whenever possible and in the best interest of developing a system of care, be flexible and creative in the use of funding to support the creation of an effective system.

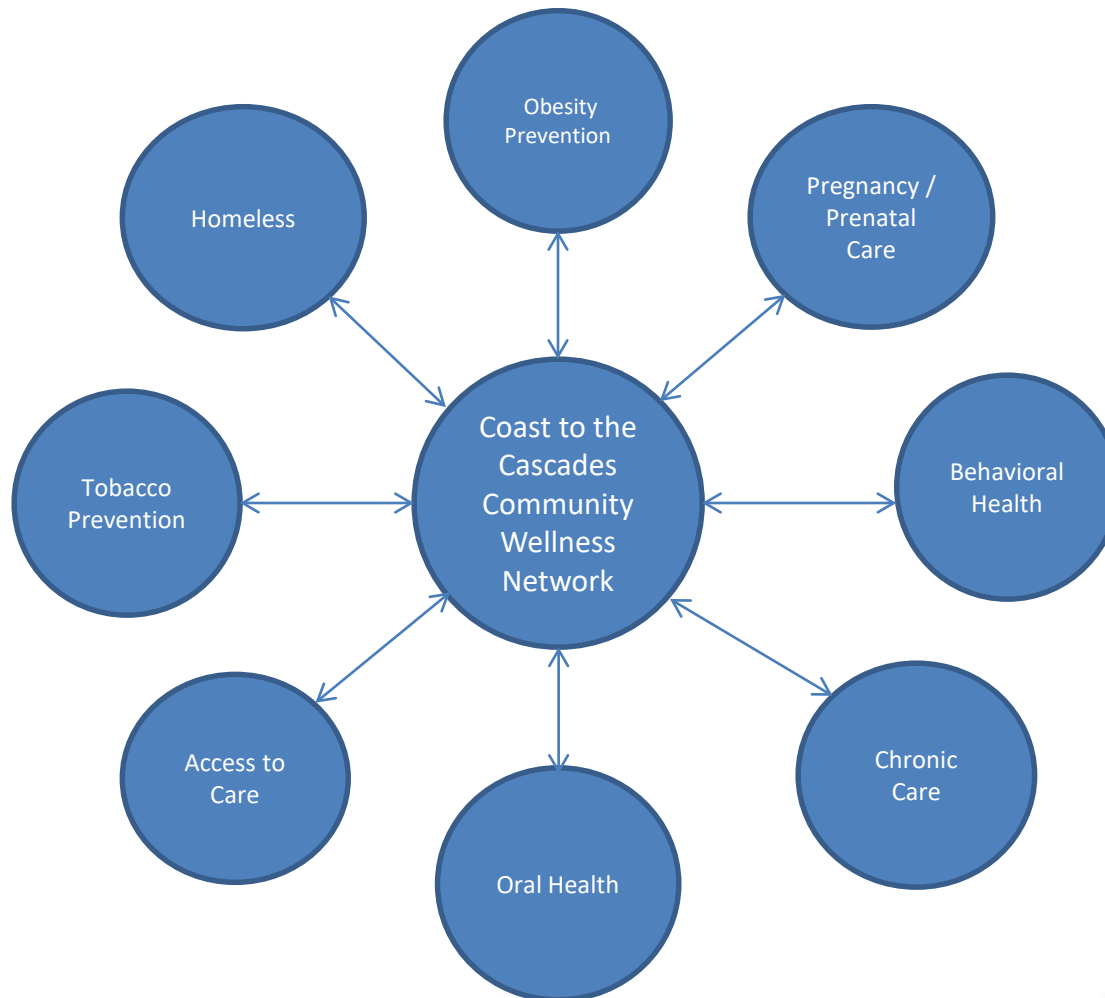

CCCWN Efforts

The CCCWN has been successful in applying for and receiving local, state and federal funds to implement strategies that improve health.

Over \$3,000,000 in grants since 2010

Benton County Oral Health Coalition

- Benton County Oral Health Coalition was formed in 2007
- Conducted a Needs Assessment in 2011
- Reviewed/Prioritized/Implemented Prevention Services
- Focus on Children
- Boys & Girls Club of Corvallis – Johnson Dental Clinic
- Collaboration with local agencies to provide adult emergency treatment services - 2012
- 14 Dentists participate
- Average patients per year – 110
- Emergency Department/Urgent Care use decreased

Linn County Oral Health Coalition

- Linn County Oral Health Coalition formed in 2010
- Conducted a Needs Assessment in 2011
- Reviewed/Prioritized Community Needs
- Focused on uninsured/underinsured adults
- Collaborated with local agencies to provide adult emergency treatment services with vouchers – 2013
- Target east Linn County
- 6 Dentists participated – Currently 3 Dentists
- Average patients per year - 48
- Emergency Department/Urgent Care use decreased

Lincoln County Oral Health Coalition

- Lincoln County Oral Health Coalition formed in 2012
- Conducted a Needs Assessment in 2012
- Loss staffing in 2012
- Reconvened in 2013
- Reviewed goals/objectives/priorities
- Identified prevention and treatment services
- Provided only dental van services for uninsured and underinsured adults

Benton, Lincoln, Linn Counties Regional Oral Health Coalition of Oregon

- Formed in 2013
- Identified common needs throughout the region
- Identified current services in the region
- Formalized relationship with CCCWN
- Developed the Healthy Smiles for All project
- Began oral health support -2014
- Began pilot – Spring 2014



Healthy Smiles for All – The Need

- Increase in Working Poor
- Decrease in dental benefits
- 2008 Oregon Health Plan Adult Basic Stopped adding clients
- Oregon Health Plan Basic dental coverage has emergent dental care only
- Increase in Emergency Department visits from adults in dental pain

- Healthy Smiles for All- May 2014
- Federal HRSA Grants & Samaritan Health Services
- Collaboration built from Regional Oral Health Coalition
- Goal is to reduce ED and UC visits
- Preventative & Treatment Program for uninsured, underinsured, low-income, homeless

Healthy Smiles for All - Vouchers

- Partnership with local Dentists
- Partnership with Capitol Dental Care
- Screening & Referral – River Center
- Schedule Appointments
- Pre-visit contact to reduce No-Shows
- \$100 for dental services



Healthy Smiles for All – Dental Vans

- Partnership with local non-profit organizations:
 - The River Center in East Linn County
- Medical Teams International provides dental vans and secures volunteer dentist.
- Non-profit organizations schedule 1 dental van per month
- 10 – 14 patients scheduled per van.



Healthy Smiles for All – Co-Location

- Pilot in Rural Linn County – August 2014
- Expanded Practice Dental Hygienists – Dentist
- Screenings, X-rays, Cleanings, Scoop & Fill
- Restoration & Extractions
- Weekly Dental Van-Capitol
- Transportation/Childcare

- Samaritan Sweet Home Family Medicine
- Capitol Dental Care – Expanded Practice Dental Hygienists
- Staff Meetings
- Permanent Exam Room
- Capitol Dental Care – Dentist
- Warm Hand-Offs
- Scheduling





Healthy Smiles for All – 2014-2018

- Dental Van Visits – 637
- Adult Emergency Vouchers – 424
- Co-location Visits – 2,247
- Healthy Smiles for All initiative continues with support from Samaritan Health Services, Capitol Dental Care, Advantage Dental and Benton-Linn Federally Qualified Health Center
