Dr. Ronald W. Naito—Honoring a Legacy of Healing

Dr. Naito, who died in December 2019 from pancreatic cancer, expressed gratitude for “the gift of time,” and focused the last 18 months of his life on transforming medical education. With the creation of the **Ronald W. Naito Directorship in Serious Illness Education**, he leaves a legacy of healing the profession he loved. Dr. Naito’s hope was that the endowment will grow to the level of an endowed chair with the resources to support more of Dr. Katie Stowers time.

Raising the Bar: Medical Student Communication Skills Continue to Improve

With support from the **Storms Family Foundation**, OHSU charts a national path in raising the bar on expectations for the compassionate communication skills of our graduating medical students. We recently completed testing of 144 medical students, evaluating their mastery in communicating honestly, compassionately and without medical jargon. This is the third class of graduating students we have tested. It is profoundly rewarding to be able to measure the impact of our interventions with the class of 2020 as a whole performing at a notably higher skill level. We provided video feedback and personal tutoring to just over 10% of the class identifying specific areas for improvement. Overall the students are remarkably compassionate in their communications and give us all so much hope for the future.

Dr. Tyler Tate Takes the Helm

The Living with Life Threatening Illness course remains one of the most popular courses in medical school. With support from the **Miles J. Edwards Chair in Professionalism and Comfort Care** and under Dr. Tate’s leadership, 93% of students rated this year’s course as “the best course in college or medical school.”

Oregon Leads POLST Innovation

The Oregon POLST Program maintains the Center’s high standards related to conflict of interest and does not accept gifts from health care industry sources. With your support we maintain a strong independent voice, while widely sharing Oregon’s innovations with others. Abby Dotson, PhD, and Susan Tolle, MD, recently hosted a webinar, “POLST: What’s New in Oregon?” to share Oregon’s newest developments and highlight challenges ahead.
