9:15 - 10:15 AM Keynote: Adopting a Workplace Bullying Policy and Putting it to Work

Edward Stern, Researcher and Writer

Edward Stern served the U.S. Department of Labor for 41+ years as an economist and policy/program analyst. He developed regulations and analyzed enforcement. For 27 years in OSHA, he modeled health and safety risks and regulatory feasibility. He innovated compliance assistance, leading teams of scientific, medical, and legal staff to develop online "OSHA Expert Advisors." DOL adopted this idea for its "elaws Advisors". EPA appointed Stern to its 2nd Compliance Assistance Advisory Committee for 2002 to 2004. Later he was OSHA's technical advisor to the U.S. Surgeon General's workgroup on Second-Hand Smoke. He presented research on abusive supervision at the LERA annual conference in 2007. He wrote the "Bullying and Psychological Aggression" chapter of "Halt the Violence" (e-book, Amazon). He was on the DOL safety and security

workgroup for six years. He was on the DOL Workplace Violence Committee, 2014-15. Now, he researches, writes, and advises on workplace bullying.
