	VISITING PRACTITIONER	<ul style="list-style-type: none"> Visiting Practitioner Visiting Physician 	Reserved for volunteer or community established licensed providers who provide continuation of health care at OHSU without OHSU compensation from any OHSU unit. These individuals do not hold Affiliate Faculty positions at OHSU.	<ul style="list-style-type: none"> Practice insurance that covers the individual's activities at OHSU Must obtain privileges though OHSU Medical Affairs Program
	INTERN	<ul style="list-style-type: none"> Non-OHSU Student Intern, paid or unpaid 	<p>Reserved for those who participate in various activities to gain knowledge, skills, and abilities for academic credit towards a degree from their home institution. These individuals are not at OHSU to participate in a practicum or clinical rotation. Additionally, these individuals are not entitled to employment/ academic enrollment. An Affiliate agreement with their home institution is required.</p> <p>For paid individuals, OHSU has an educational obligation to review their performance, and they are compensated from an outside source or if they are part of a formalized internship program, through OHSU Accounts Payable.</p>	<ul style="list-style-type: none"> Affiliate agreement
	VOLUNTEER	<ul style="list-style-type: none"> Altruistic Volunteers Experiential Volunteers Episodic Group Programs Observer/Shadow Healthcare Volunteers 	<p>Reserved for those who donate their time and service without compensation in either a selfless effort to fulfill OHSU's mission, or for educational experience in order to gain knowledge, skills, and abilities to propel them towards their future professional or educational goals. Skill sets are not typically required and these individuals are not entitled to employment/academic enrollment.</p> <p>For educational opportunities, these individuals may be unpaid, or may be compensated from an outside source or through OHSU Accounts Payable. Duties assigned to educational opportunities cannot be similar in scope to that of paid positions at OHSU.</p>

	<ul style="list-style-type: none"> EMERITUS FACULTY 	Reserved for retired faculty who have continued privileges with OHSU (e.g. OHSU email address, ID badge, keys, access to library and other resources, space, etc.) who are not compensated from any OHSU unit.	<ul style="list-style-type: none"> Hosting Schools & Programs
	<ul style="list-style-type: none"> STUDENTS ON CLINICAL ROTATION/PRACTICUM 	Reserved for those who participate in clinical activities to gain knowledge, skills, and abilities for academic credit towards a degree from their home institution (or OHSU if they are an OHSU student). For these individuals, OHSU has an educational obligation to review their performance, and they may be compensated from an outside source or through OHSU Accounts Payable. Additionally, these individuals are not entitled to employment/academic enrollment.	<ul style="list-style-type: none"> Hosting Schools & Programs
	<ul style="list-style-type: none"> VENDORS CONTRACTORS 	Vendors and external business partners from whom OHSU purchases supplies and/or contracts work from.	<ul style="list-style-type: none"> Departments with contracting authority (e.g. Logistics, Legal or Tech Transfer)

ESCORTED VISITORS	<ul style="list-style-type: none"> OBSERVER/SHADOW 	Reserved for those who come to observe and/or shadow OHSU personnel for fewer than 30 days, do not need network access and are not participating in any capacity. If any of these items are needed, this type of visitor will need to be onboarded through OVV. See "Volunteer" classification.	<ul style="list-style-type: none"> Hosting Department
	<ul style="list-style-type: none"> AUDITORS INSPECTORS SURVEYORS STUDY MONITORS 	Reserved for those who are visiting OHSU to review OHSU operations or research activities for the purposes of assuring compliance with legal, regulators, certification, or accreditation requirements.	<ul style="list-style-type: none"> Hosting Department
