## CDC: SPECIAL GUIDANCE FOR PEDIATRIC VACCINES

CDC recommends vaccine recipients receive the recommended age-appropriate vaccine product and dosage **BASED ON THEIR AGE ON THE DAY OF VACCINATION**. CDC provides guidance on this routine recommendation and allowable alternative options.
