### **Washington Update**

### **Preparing for Your RHC Survey**

Do you remember the last time your RHC had a recertification survey? Recertification surveys for non-deemed RHCs are required to be completed so that no more than seven years elapse between surveys. This presentation will address the current regulatory requirements and how your clinic can prepare for an upcoming recertification survey. Janis will also answer FAQs and the not-so-frequently asked questions that have come up over the last two years.

### **Understanding Commingling in an RHC**

Commingling is a frightening but misunderstood topic for Rural Health Clinics. This session will help sort through commingling and how Medicare defines it. We will discuss several aspects of possible commingling scenarios and how to avoid them. Our conversation will distinguish the difference between billing defined non-RHC services during RHC hours versus doing so with professional services. Several floorplans and building scenarios will be reviewed, as well as those scenarios which are more likely to be allowed. Topics will include:

- Commingling definitions;
- Cost reporting considerations;
- Duplicate reimbursement;
- Non-RHC hours vs non-Rural Health Clinic services;
- Patient treatment areas; and
- Specialty clinics.
