























Moving Knowledge Instead of Patients and Providers

Oregon Rural Practice-based Research Network

Oregon Rural Practice-based Research Network (ORPRN) was founded in 2002 with 6 practices. Over 400 statewide practices now participate in a current or recent ORPRN project or program. In 2017, ORPRN created the Oregon ECHO Network to provide telementoring programs to clinicians across Oregon.

• A Practice based Research Network is a group of ambulatory practices devoted principally to the primary care of patients, but affiliated in their mission to investigate questions related to community-based practice and to improve the quality of primary care

ORPRN's mission is to improve health outcomes and equity for all Oregonians through community partnered dialogue, research, coaching, and education.

In addition to our OEN projects, we currently have ongoing 15 funded research projects and 6 funded improvement and transformation projects with participation from practices in every county in the state, covering a number of clinical, policy and practice related topics.

What are Communities of Solution?



Community of Solutions

"local decision making is of paramount importance" (Folsom Group)

- 1967 Folsom Report created the Phrase
- Communities of Solution (COS) recognize that "complex political and administrative structures hinder problem solving"
- COS include links between "community, public health, and primary care" and to be grounded in patient-centered care

Communities of Solution- Examples

- Health promotion promotores (culturally and linguistically appropriate CHWs)
- Boot camp translation (identifying health problems and translating best medical evidence into actionable projects)
- OCHIN project (locally relevant data sharing among public health partners, community health stakeholders, informatics, and policy)
- Social determinants of health (nurse-led teams working within food pantries)





HEAL-OR Project



Health Equity, Access and Quality Improvement using Project ECHO in Rural Oregon (HEAL-OR) Project

- 1 of 9 national recipients of HRSA's Telehealth Technology-Enabled Learning Program grants in 2021
- Five-year project, totaling \$2.375 million dollars of funding
- Focusing efforts in six rural counties in Oregon (Hood River, Wasco, Gilliam, Sherman, Baker and Umatilla) specifically for Latino/x/e patients and older adults



Latino/x/e Population in Service Area have Significant Health Needs

- Growing Latino population Latinos are 14.1% of Oregon's population, 15.6% of the rural population and 21.7% of the target service area with a high of 33% in Hood River County
- Poverty rate among Latino Oregonians is nearly double the rate for whites
- Oregon Latinos have higher rates of lack of insurance coverage. In 2019, 11.5% of Oregon Latinos lacked health insurance compared to just 5.3% of non-Latino Oregonians.(10)
- Diabetes is the fifth leading cause of death in the Latino population and 15.6% of Oregon Latinos have diabetes compared to 8.1% of whites
- COVID-19 has also disproportionately affected the Latino population. In OR, Latinos have been 3 times more likely to test positive for COVID (8685 per 100,00) vs 2917 per 100,00 for non-Latinos).
- Lower COVID-19 Vaccination Rates: As of June 18, 2021, 42% of Latinos in Oregon were vaccinated compared to 59% of whites. In our service area, 42% of Latinos in Hood River, Wasco, Gilliam and Sherman counties had been vaccinated and only 28% in Umatilla and Baker counties.(17)





HEAL-OR Project Primary Objectives:


- Objective 1 is to create a Rural Advisory Panel (RAP)
- Objective 2 is to utilize the Project ECHO (Extension for Community Healthcare Outcomes) learning community model to improve health equity, access, and quality in rural Oregon by offering three, fixedlength ECHO programs each year, focused in adult mental health, diabetes, and Long COVID

RAP Activities to Date

- Fall 2022 (potential partner meetings, signed scopes of work, board compensation for physical and behavioral health clinicians)
 - Goals: clear expectations and benefits of participation, compensation for time
- January 2022 (first quarterly advisory board meeting)
 - Goals: introductions, introduce the diabetes ECHO and request feedback, brainstorm what encouraging ECHO participation looks like in their community
- April 2022 (second quarterly advisory board meeting)
 - Goals: discuss Long COVID ECHO (understand community needs), provide updates on Adult Mental Health ECHO
- July 2022 (third) quarterly advisory board meeting)
 - Goals: share participation information in Diabetes ECHO, discuss creating ECHO champions in your community
- August 2022 (site visits to Gorge region and Eastern Oregon)
 - * Goal: meet in person with partners, engage new stakeholders, build relationships





Keys to Success: What We Think is Working


- Compensation for the rural advisory board panel members
- Clear expectations and benefits of participating (scopes of work)
- Focused meeting agendas and minimal communication outside of planned meetings
- Open communication about goals and progress of HEAL-OR ECHO programs
- Survey the RAP members each year to understand what is working well and what can improve
- Site Visits are Key- they allowed us to build on partnerships and expand our participation
