10:45 - 11:45 Integrating Patient and Worker Safety in Critical Access Hospitals: A Need in the Pandemic Aftermath

David Hurtado, ScD, MSc, Assistant Professor, Oregon Institute of Occupational Health Sciences, Oregon Health & Science University, OHSU-PSU School of Public Health Critical access hospitals (CAHs) need to revitalize their safety efforts in the wake of the COVID-19 pandemic. Renewed safety efforts must address long-standing and emerging issues with depleted resources and a demoralized workforce. One promising response to this challenge is addressing problems that intersect worker and patient safety. This

presentation will provide an overview of the safety situation for CAHs in the pandemic aftermath and will present an example of a program that was effective in reducing patient-assist injuries—an area that integrates patient and worker safety. We will discuss the principles that explain effectiveness with their implications for research and practice.

Roza Tammer, MPH, CIC, Infection Prevention & Control Epidemiologist, OHA, Public Health Division, Acute & Communicable Disease Prevention, Healthcare-Associated Infections Program Impacts of the shortage of experienced infection prevention staff on critical access hospitals have included high turnover, high variability in duties between facilities and health systems, and the need to fill vacancies on an interim basis. The Oregon Health Authority's Healthcare-Associated Infections (HAI) Program liaises between the state Public Health Division and health care settings statewide and offers resources for quality and infection prevention staff. Learn a brief history of the development of infection prevention programs as well as state-level HAI programs, an overview of the broad scope of work – and essential responsibilities – of an infection preventionist, and linkages with the OHA HAI Program and other public health resources for building infection prevention and control capacity.

10:45 - 11:30 Improving the Timeliness of Stroke Care through Lean Process Improvement
Theresa Via, Director of Quality Resources, Samaritan North Lincoln Hospital
In 2022 SNLH identified that their CAH was not providing stroke care that was consistent
in meeting both quality and timeliness standards as defined by AHA GWTG. They were too
often falling out of best practice for time to CT, time to CT interpretation and time to
thrombolytic. Based on hospital data, a decision was made to form a Lean Six Sigma team
to improve the timeliness of stroke care. This presentation will show how SNLH utilized
Lean Six Sigma tools to make significant improvements in processes to consistently
achieve the AHA GWTG stroke targets.

This engaging presentation takes participants on a journey of dead ends, discovery and hidden gifts. Following a surprise physician resignation, a rural hospital obstetrics service is at risk.
