An Advance Directive is a legal form where a person:

- States what medical care they would want if in the future they could not speak for themselves.
- Chooses a health care representative to speak for them - only if they cannot speak for themselves.

Started with listening sessions:

Facilitated by Community Health Workers (CHWs) with English and Spanish speakers in Hood River and Wasco Counties of the Columbia Gorge, including a group of bilingual CHWs.

Goal: To learn what understanding and thoughts were about the AD and related topics.

Facilitated by medical provider with providers.

Goal: To learn what providers' interests and observations were related to the AD.

Key findings from community listening sessions:

- Many do not know about the AD, especially so in Latinx/Spanish language Listening Session.
- Thinking about it and talking about it is very terrifying, uncomfortable, sad.
- Talking about it could make it happen.
- For those who knew about the AD, confusion between POLST (Portable Order for Life Sustaining Treatment) and AD.

In Grant 2, we...

...did intensive outreach with Latino community in Spanish and also English.

- Spanish language radio
- Spanish language community Zoom meetings
- Orchards
- Community events like Covid vaccine and food distribution events

Current work (3rd grant)

To support Spanish speaking community members in starting to fill out their AD, or completing their AD:

- Attend existing events with info sheet and AD forms.
 Those who write contact info in form receive \$5 restaurant gift card.
- Hold four events to support people in understanding and starting to fill out their AD. Participants receive snacks, gift card and there is a raffle.
