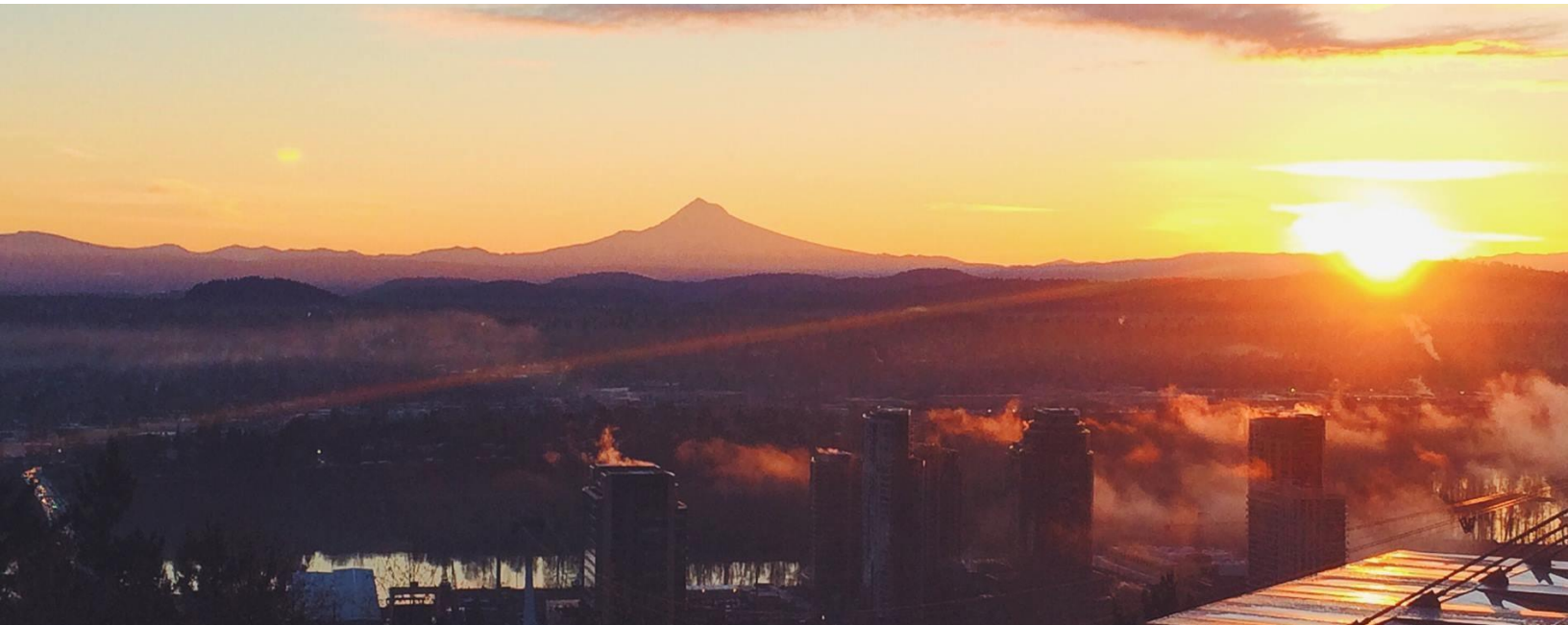

# **The OHSU Introductory FEES® Course**

*The OHSU Introductory FEES course is a two day foundation course designed to provide speech-language pathologists and other licensed professionals with the necessary skills to begin implementing of Fiberoptic Endoscopic Evaluation of Swallowing (FEES) at their institution.*

**Overview:** The OHSU Introductory FEES course is a two-day foundation course designed to provide SLPs, ENTs and other licensed medical professionals with the necessary skills to begin implementation of the FEES procedure in their institution. Combining lectures with hands-on training, the workshop is taught in a small-group seminar format over two consecutive Saturdays. Class size is limited in order to maximize learner outcomes and to ensure adequate hands-on endoscopy training. Training occurs using the equipment in the NW Center for Voice & Swallowing at OHSU. The course is taught at an Advanced level and assumes proficiency with dysphagia diagnosis and management. Those with previous dysphagia experience in a medical setting will likely benefit most from the training.

**Learner Outcomes:** On the conclusion of this program, participants will be able to:

1. Discuss what can be understood about normal and abnormal swallowing from an endoscopic image.
2. Describe clinical indications and risks for performing FEES.
3. Follow a protocol for administering a FEES exam.
4. Identify key structures, interpret findings, and apply therapeutic interventions during the FEES exam.
5. Describe how to adapt the FEES protocol for different patient populations and settings.
6. Discuss how to manage patients with dysphagia using endoscopy during evaluation and therapy sessions.
7. Demonstrate an introductory level of skill in passing the endoscope safely and know how to position the scope to get an ideal view during the FEES exam.

He developed the OHSU FEES course in 2003 and teaches it annually.



**Donna Graville, PhD, CCC-SLP** is an Associate Professor and the director of the OHSU-Northwest Center for Voice and Swallowing. She earned her Master's degree in speech and hearing sciences at Portland State University and completed her fellowship at the Portland V.A. Medical Center. Her desire to develop a comprehensive voice and swallowing center led her to pursue a Ph.D. in communication disorders and sciences at the University of Oregon. She co-teaches the OHSU FEES course annually.



**Rachel Bolognone, MS, CCC-SLP** earned her M.S. in Speech-Language Pathology at the University of Arizona. She is an Assistant Professor in OHSU's NW Center for Voice and Swallowing and Adjunct Faculty in the Department of Speech and Hearing Sciences at Portland State University. Rachel's expertise includes the treatment and management of swallowing disorders of various kinds. She specializes in the rehabilitation of patients treated for head and neck cancer in inpatient and outpatient multidisciplinary settings. She co-teaches the OHSU FEES course annually.
