Over 18-months, SCH embarked on creating and adopting a strategic plan that reinforced the importance of quality outcomes, employee engagement and a leadership model of transparency and inclusion. SCH sought and obtained DNV accreditation, the first accreditation the hospital has ever had in its 23 years of existence, and through months of hard work and dedication across the organization using SMART GOALS, bedside rounding, adopting JUST CULTURE and other quality improvement methods, they have seen transformational change. Together, these strategies resulted in improved employee engagement and patient satisfaction.
