### What is the Frontier Veggie Rx program?

- A produce prescription program designed to address food insecurity and increase intake of fresh produce in Eastern Oregon
- Offers are used to purchase fresh or frozen fruit and vegetables at local participating stores





# What are the goals of the FVRx program?

- Increase consumption of, access to, and variety of produce at local rural and frontier retailers
- Reduce barriers to accessing produce
- Improve health outcomes
- Support local retailers





### How does it work?

- Prescribers and local retailers are trained by FVRx program manager
- Individuals and families are screened for eligibility
- Screen positive, paper voucher or IQPay offer provided
  - \$30/month single person household
  - \$60/month two+ person household
- Program operates for 12 months



- 2019 added Gilliam and Harney Counties
- 2020 added Wheeler County
- 2021 added Lake County
- 2022 added Malheur County
- 2023 added Baker County
- 2025 added Grant, Umatilla, and Wallowa Counties

Each county must vote to use all or part of their allotted LCHP funds



- GOBHI commitment
  - O Program Manager
  - Cover travel
  - O Printing & shipping vouchers- working on technology advancement
- EOCCO commitment
  - Annual support with SHARE funds
  - O Partner for implementation of the 1115 Waiver Produce Prescription
  - Benefit in June 2026
- Local Community Health Partnerships
  - O Use LCHP funds for project
  - Provide prescribers
  - Provide introductions to vendors
  - Raise additional funds, if needed



### **Prescribers and Vendors**

#### Prescribers

- Nice to have at least 2 per county (Need to have at least 1 per county)
- Must attend training prior to starting prescribe
- Computer/internet access
- Good community relationship
- Challenging but doable in frontier communities

#### Vendors

- O Need at least 1 per county
- O Agree to participate- attend training and sign agreement
- Invoice for reimbursement
- O Farmer's Markets, local grocery stores, gas stations, fruit stands, private growers

### Paper Vouchers

- Used in: Gilliam, Grant, Malheur, Sherman, and Wheeler Counties.
- Booklet of 15 coupons at \$2.00 each.
- Shipped directly to Prescribers.
- Printed at Bohn's Printing in The Dalles.
- \$1.25 printing cost plus shipping costs per each paper booklet.
- During COVID moved to mailing booklets to participants.
- Retailers mail invoice plus received vouchers for reimbursement.
- Program Manager reviews invoices and submits payments


### **IQPay Digital Offers**

- Used in: Baker, Harney, Lake, Umatilla, and Wallowa Counties.
- 6 month cadence offers.
- QR code received via text (or email).
- Prescriber or member must print QR code from email.
- \$1.90 per month per offer.
- IQPay submits monthly invoice to GOBHI for payment
- Program Manager reviews invoices and submits payment



### IQPay Offer

- Utilizes a Smart phone or email address to access offers.
- Albertsons Companies paid for the set up and implementation of the IQPay system.
- GOBHI is in contract with IQPay for this service.
- More cost effective than paper vouchers.

We are working to operationalize IQPay at all frontier FVRx vendors - starting in Gilliam and Wheeler Counties - Challenging implementation.


