News Highlights & Program Updates

OBHC Kicks Off with Visit from Dr. Mary Ann Abrams

The Oregon Bioethics and Humanities Colloquium (OBHC) kicked off its 2025-2026 academic year of lectures on October 15th with a visit from Dr. Mary Ann Abrams of Ohio State University College of Medicine and Nationwide Children's Hospital. The Center for Ethics partnered with the Department of Pediatrics for the OBHC kick off lecture. Dr. Abrams, a national expert in health literacy, presented "Organizational Health Literacy: The Foundation for Achieving Health and Well-being" to a large and broad audience of pediatricians and ethics enthusiasts. This year, OBHC will host its virtual lectures one Friday per month from noon to 1 p.m. through June. See the upcoming events section below for additional details.

Health Literacy Symposium Provides Hands-on Skills Practice

The Center for Ethics co-hosted the second annual OHSU Health Literacy Symposium on October 16th in partnership with OHSU Brand Strategy. Chaired by Dr. Cliff Coleman, this year's symposium focused on skills-building of health literacy and clear communication best practices that can be applied in clinical services, research, and health professions education. Dr. Mary Ann Abrams, a national expert in health literacy and the use of teach-back, was the keynote speaker for the symposium. This year's symposium had a broad audience, and registrations included many people across the Portland-metro down to Eugene, Roseburg, and even out-of-state.

TalkOregon Receives New Grant to Teach Rural Nursing Students

Dr. Katie Stowers has received a new three-year grant from The Kinsman Foundation for the TalkOregon program. This grant will allow TalkOregon to pilot the integration of serious illness communication skills training into undergraduate nursing programs in Klamath Falls and La Grande. The grant will also provide continued support to TalkOregon's existing statewide partnerships established during the current 3-year grant from The Kinsman Foundation. The Center for Ethics greatly appreciates our continued partnership with The Kinsman Foundation.

Oregon POLST Program Creates Educational Resource for Skilled Nursing Facilities

The Oregon POLST Program has collaborated with Coalition stakeholders in long-term nursing care and the Oregon Department of Human Services' Safety, Oversight, and Quality to create a double-sided, educational card for staff at skilled nursing facilities to support the appropriate use of POLST in these settings. This quality improvement effort will help ensure that nursing facilities are using POLST in accordance with best practices. Distributions of these cards to all 128 Oregon-based skilled nursing facilities will begin by the end of this year.

Get to Know Dave Hoyt, the Center's Statewide Ethics Education Coordinator

Dave Hoyt joined the Center for Ethics in March 2022 as the Statewide Ethics Education Coordinator supporting the Madeline Brill Nelson Chair in Ethics Education and the Miles J. Edwards Chair in Professionalism and Comfort Care. Dave plays an essential role in planning, coordinating, and connecting others to make many events happen throughout the year, such as the annual Kinsman Bioethics Conference, Oregon Bioethics and Humanities Colloquium (OBHC) lecture series, the annual Madeline Brill Nelson lecture, the Living with Lifethreatening Illness course, and Pain Intersession. Dave is truly the glue that holds all of the ethics programs together.

Dave first started working at OHSU in 2006. In 2017, he received a Golden ROSE award for service excellence for his work in helping new patients navigate Oncology. Prior to joining the Center, he was the Emergency Medicine Residency Program Coordinator. It was in this role during the Covid-19 pandemic that Dave watched clinicians struggle with burnout and mental health wellness. He realized that organizational obstacles existed that were difficult for conscientious providers to overcome. These dynamics are what motivated Dave to join the Center for Ethics, as he saw the Center as a place where they could be addressed.

Born and raised in Oregon, Dave says "Oregon is more than my home, it makes up a piece of my identity. My family has always worked in public service and an effort to improve my local community is ingrained in me." He loves being able to work on projects that have a statewide impact, being a facilitator and advocate, and connecting people together for innovative projects that benefit Oregonians across the state.
