<b>Q12.</b> Project summary: Include why you would like to do this project, and what you will do (describe your main activities).	Describes in great detail why they are doing the project and details multiple project activities. It is clear that the project benefits disability communities and <b>clearly describes connection</b> to improved health and wellness	Gives some details about why they are doing the project <b>and</b> project activities - project has benefit for disability communities and <b>implied connection</b> to improved health and wellness	Gives some details about why they are doing the project <b>or</b> about the activities - project could benefit disability communities or lacks clear explanation of improved health and wellness	Project summary is unclear: why they are doing the project or what they will do is unclear	no answer
<b>Q13.</b> Describe your overall project timeline. <b>Q15.</b> How does this project reach or include underserved communities, including communities that represent the intersection of other identities in addition to disability?	Project <b>includes direct partnership and engagement</b> with underserved communities beyond disability generally. May provide specific examples of partnership or outreach activities or might explain how programs have been adjusted for communities.	Project includes <b>some outreach to, or engagement with,</b> underserved communities beyond disability generally. May hint at partnerships or outreach, or how programs have been adjusted for communities.	Project is <b>open/available to all</b> , including underserved communities beyond disability generally.
