Employee STRENGTH

Topic: Employee STRENGTH (sometimes referred to as the "Employee-CHW Benefit" internally) is an employee assistance program where OHSU staff members are offered confidential access to Community Health Workers (CHWs). CHWs support employee needs by connecting them to both external support and services (i.e. social services, housing, food/utility resources) and internal OHSU resources (i.e. benefits programs, on-campus support). Current rollout is limited to 6 departments at OHSU, including Sterile Processing, Environmental Services, Food and Nutrition Services, Custodial, Patient Transportation, and is currently expanding to departments on floor 7 of Doernbecher Children's Hospital. The program will continue to spread to additional departments. Future implementation beyond OHSU is projected to include organizations both within Oregon and beyond.
