HCI Workforce Development in Rural and Frontier Oregon

Health care interpreters (HCIs) enable communication between patients and care teams, addressing inequities rooted in language barriers. In 2024, less than 15% of patients needing HCI services received them, and rural and frontier patients are often less likely to receive these needed HCI services. An OHA-approved training addresses a workforce gap in rural and frontier areas through an innovative, blended remote and in-person format, growing the workforce already in place and most likely to stay in their communities. This presentation will discuss effective course design strategies to respond to rural and frontier HCI needs and challenges.

Zero Harm in a Rural Setting: How Two Critical Access Hospitals Eliminated Hospital-Acquired Conditions

Jessica Hubbard, MPH, BSN, RN | Samaritan North Lincoln Hospital

In 2025, two Critical Access Hospitals (CAHs) on the Oregon coast achieved zero hospital-acquired conditions, including CLABSI, CAUTI, and C. difficile infections. Samaritan North Lincoln also reported zero surgical site infections. This success was driven by daily maintenance of lines and drains, Epic tools and embedding best practices into clinical documentation. The antimicrobial stewardship program ensured antibiotics were fully infused within 30 minutes prior to every incision, and multidisciplinary hospital-acquired condition (HAC) teams focused on prevention strategies and rapid problem-solving. Attendees will learn practical strategies to replicate these results, reduce harm and build reliability in rural settings.

The Change in Scope Process for RHCs and FQHCs

RHCs and FQHCs are paid by the prospective payment system (PPS) encounter rate and are eligible to have this rate adjusted through the change in scope (CiS) process. A CiS looks at changes these clinics and health centers make that affect type, intensity, amount and duration for services provided. This session will review the rules around this process, needed documentation and common issues.

Making Respiratory Viral Risk Data Accessible: Tools for Public Awareness in Rural Communities

Marta Fisher | North Central Public Health District

Public health departments have an obligation to report current issues to residents; however, in rural communities, small numbers lead to more volatile data. North Central Public Health District created a respiratory risk rating that aggregates percent positivity, syndromic and wastewater surveillance data from across the region into a single rating. Wastewater surveillance strengthens case-based surveillance systems by providing community-level data independent of symptoms, healthcare-seeking behavior, and testing access. Oregon's program now includes COVID, influenza A/B/H5, RSV and measles, and data can be accessed through state and national dashboards. This presentation will discuss the program's creation and challenges, with specific background on wastewater surveillance.

The Protecting Oregon Farmworkers (POF) Program was created in 2020 to help address these challenges. The program works with local community partners to help farmworkers access healthcare services along with critical SDoH supports like food and housing. This presentation will demonstrate how a team of CHWs can lead a regional collaborative, facilitate state-approved CHW certification training, support continuing education and provide mentorship.

While this connection has long been understood, investments through the 1115 Medicaid waiver accelerated efforts to formalize infrastructure supporting local partnerships. Oregon communities are adopting diverse approaches and strategies to meet these needs, and include expanding the role of CHWs, developing social care networks and community care hubs, and establishing formal agreements through data-sharing partnerships and governance structures. Launching a New Health Occupations CTE Center to Expose Rural Students to Healthcare Careers

In 2025, Sky Lakes and Klamath Union partnered to launch a new CTE center, partially funded by a Future Ready Oregon Grant. This session will explore the collaboration between school districts, Klamath Community College and Oregon Tech that led to the rapid expansion of education opportunities for underserved high schoolers to explore vibrant healthcare careers. This initiative captures excitement for the future through on-site observation, dual-credit classes and mentorship for job-ready skills or collegiate programs for over 300 students in the 2026/27 school year.
